### Footnotes:

- 1 Data expressed in imperial and metric units of measure may not always be equivalent due to rounding.
- 2 Prior to 2018, fresh eggplants, other fresh fine herbs, fresh kale and fresh sweet potatoes were included in the other fresh vegetables category. As of 2018 they are published in their own categories in this table.
- 3 "Commodity names have been adjusted to align with the Variant of North American Product Classification System (NAPCS) Canada 2017 Version 2.0 - Agricultural goods. These commodities include fresh and processed vegetables.
- 4 "Fresh cabbage" includes the following products according to the North American Product Classification System: fresh regular cabbage (114221321), fresh Chinese cabbage (114221322) and fresh kale (114221323). For the purpose of this table, other fresh non regular cabbage (114221324) is included in the other fresh vegetables commodity, and not with fresh cabbage.
- 5 "Fresh carrots" includes the following products according to the North American Product Classification System: fresh baby carrots (114221112) and fresh regular size carrots (114221111).
- 6 "Fresh cucumbers and fresh gherkins (all varieties)" includes the following products according to the North American Product Classification System: fresh cucumbers (11422152) and fresh gherkins (11422153).
- 7 "Fresh lettuce" includes the following products according to the North American Product Classification System: fresh head lettuce (114221311), fresh leaf lettuce (except mixed lettuce) (114221312) and fresh mixed lettuce (114221313).
- 8 Prior to 2018, all radishes were published together in the "Fresh radishes" category. As of 2018, the "Fresh radishes" category has been split into "Fresh radishes (except Asian radishes)" and "Fresh Asian radishes."
