WORKERS COMPENSATION ACT

GENERAL REGULATIONS AMENDMENT

Made by the Workers Compensation Board and approved by the Lieutenant Governor in Council under the *Workers Compensation Act* R.S.P.E.I. 1988, Cap. W-7.1:

1. Subsection 9.1(1) of the *Workers Compensation Act* General Regulations (EC831/94) is revoked and the following substituted:

9.1 Occupational diseases, fire inspector or firefighter

(1) The diseases and corresponding minimum periods of employment set out in the following table are prescribed for the purposes of subsection 84.1(1) of the Act:

Disease	Minimum Period of Employment
(a) multiple myeloma	15 years
(b) primary leukaemia	5 years
(c) primary non-Hodgkin lymphoma	20 years
(d) primary site bladder cancer	15 years
(e) primary site brain cancer	10 years
(f) primary site breast cancer	10 years
(g) primary site cervical cancer	10 years
(h) primary site colorectal cancer	15 years
(i) primary site esophageal cancer	25 years
(j) primary site kidney cancer	20 years
(k) primary site lung cancer	15 years
(l) primary site ovarian cancer	10 years
(m) primary site pancreatic cancer	10 years
(n) primary site penile cancer	15 years
(o) primary site prostate cancer	15 years
(p) primary site skin cancer	15 years
(q) primary site testicular cancer	10 years
(r) primary site thyroid cancer	10 years
(s) primary site ureter cancer	15 years

2. These regulations come into force on June 21, 2025.

EXPLANATORY NOTES

SECTION 1 revokes and replaces subsection 9.1(1) of the regulations to alphabetize and number the items in the table and add the following diseases to those prescribed as occupational diseases in relation to fire inspectors or firefighters:

- primary site cervical cancer
- primary site ovarian cancer
- primary site pancreatic cancer
- primary site penile cancer
- primary site thyroid cancer

SECTION 2 provides for the commencement of these regulations.
