If you request an oral hearing, you will be notified of the date, time and location of the hearing. If you fail to appear, without prior notice to the Registrar, your right to an oral hearing is deemed to have been waived.

The fee for an application for review is \$50.00. If you are requesting an oral hearing, you must do so at the time of filing this application and pay an **additional** hearing fee of \$50.00. The fee(s) must accompany this application (cheques or money orders should be payable to "Minister of Finance" and are refundable if the review results in the revocation of the impoundment. The fee for the release of a motor vehicle on compassionate grounds is \$50.00.
