# ***Application for Real Property Tax Deferral Program for Senior Citizens***

## ***General Information***

### **Purpose**

This program lowers the cost of living for eligible seniors by allowing those interested in the program to apply for a deferral of property taxes on their principal residences.

### **Who Is Eligible**

You may qualify for the program if you:

- 1) are 65 years of age or older;
- 2) have occupied your principal residence for at least six months in the year preceding the date of application; and
- 3) have an annual household income less than \$42,000.

### **How it Works**

Upon acceptance into this program, annual property taxes are deferred. Taxation and Property Records will keep an accumulated total of taxes owing each year. Should you decide to sell the property, all deferred taxes become payable.

If you continue with the program for life, the accumulated taxes are required to be paid out of the estate.

Under the Real Property Tax Deferral Program for Senior Citizens, interest does not accumulate on the deferred taxes from the date of approval.

### **Conditions**

You must have occupied your home for at least six months in the year preceding the date of applying for a deferral certificate.

If you own and occupy part of a multiple family dwelling, such as half a duplex, the taxes can be deferred only on the portion you occupy.

On commercial properties, farm properties or properties exceeding one acre, taxes can be deferred only on the house and lot (typically one acre) on which the house is located.

Taxes can be deferred on only one property. For example, if you own both a winter home and a summer cottage, you could seek a tax deferment only on your principal residence.

### **How to Apply**

Complete and return the application form to Taxation and Property Records with a copy of last year's income tax return(s) for each person residing within the residence. If your application is approved, you will receive a deferred tax certificate in the mail. You will also receive an annual statement informing you of the total taxes deferred under this program.
