FAMILY LAW REFORM ACT Chapter F-3

REGULATIONS

Made by the Lieutenant Governor in Council under the *Family Law Reform Act R.S.P.E.I.* 1988, Cap. F-3.

1. Statement of property

A statement of property pursuant to section 5 of the *Family Law Reform Act* shall disclose the particulars of property set out in Form 1 of the Schedule. (*EC1024/78*)

2. Statement of financial information

A statement of financial information pursuant to section 23 of the *Family Law Reform Act* shall disclose the particulars of property set out in Form 2 of the Schedule. (EC1024/78)

3. Designation of matrimonial home

A designation of a matrimonial home under subsection 35(1) of the *Family Law Reform Act* shall be in Form 3 of the Schedule. (EC1024/78)

4. Cancellation of designation

A cancellation of a designation of a matrimonial home under subsection 35(3) of the *Family Law Reform Act* shall be in Form 4 of the Schedule. (EC1042/78)
