I am pleased to submit the annual report for the Department of Social Development and Housing for the fiscal year ending March 31, 2021.

This report summarizes the achievements of the department for that year. Some highlights include:

- 742 of the 1,200 committed new affordable housing units were initiated;
- Significant COVID-19 related funding assistance to multiple non-governmental organizations (NGOs) for additional support needs during those challenging times;
- New Affordable Housing Program launched to provide incentives to private developers to create affordable housing units for Island residents;
- Significant investments in Social Programs including \$7.5 million to increase the AccessAbility Supports Program; and
- Launch of a Secure Income Pilot to assist high need Islanders with financial assistance.

As well as reporting on the activities of our department during that period, this report satisfies the requirements of Section 5 of the *Rehabilitation of Disabled Persons Act*, Section 10 of the *Social Assistance Act* and Section 20.1 of the *Supports for Persons with Disabilities Act*.

Department Overview

With approximately 400 employees and expenditures of more than \$160 million, the Department of Social Development and Housing is a significant provider of services to the citizens of Prince Edward Island. The department delivers programs and services from its four divisions: Child and Family Services, Social Programs, Housing Services, and Planning, Policy and Innovation. The Department is supported with finance, communications, human resources and information technology through other departments and agencies of the Government of Prince Edward Island.

Vision, Mission and Values

The needs of Prince Edward Island's citizens are changing, and we must continually improve our services and the way we provide them. The strategic plan "Our People, Our Families, Our Communities 2018-2023" guides us as we focus on both the department and the people we serve. It sets the direction for the Department of Social Development and Housing for the upcoming years.

Vision:

Empowering individuals and families to be safe, healthy, secure and connected with communities.

Mission:

We contribute to the well-being of individuals, families and communities by working collaboratively, in an innovative manner, to promote the development of healthy, self-reliant individuals.

Values:

- 1. Respect The attitude of acceptance and inclusion.
- 2. Integrity The quality of being non-partisan, honest, open and fair.
- 3. Accountability The practice of being responsible, transparent, and willing to accept responsibility for one's actions.
- 4. Excellence The desire to provide high levels of accuracy, proficiency and knowledge in performing our work and in delivering services to the public.

Services Provided

Child and Family Services

The Child and Family Services Division provides a wide range of programs, services and resources to children and families across the province, including child protection services, group homes, foster care, adoption and parental and family supports.

Social Programs

The Social Programs Division provides services in such areas as Social Assistance, AccessAbility Supports, Child Care Subsidy and the Seniors Independence Initiative. The Social Programs Division also provides funding grants to community organizations to provide residential services for persons with disabilities.

Housing Services

The Housing Services Division provides services in the areas of affordable housing for seniors and families and supports emergency and transitional housing supports for Islanders in need. Housing Services also provides home renovation programs that support seniors and low-income families to make repairs that make their homes safer.

Planning, Policy & Innovation

The Planning, Policy and Innovation Division provides program analysis and evaluation, departmental reporting, federal/provincial/territorial relations, legislative coordination and emergency social services.

Office of Seniors

The Department of Social Development and Housing supports Island seniors through a variety of programs and services in addition to engagements with the Seniors' Secretariat - a body created to provide policy and program advice to government and other organizations to improve the quality of life for seniors living in Prince Edward Island.

Highlights and Accomplishments

The following improvements were made to programs and services during 2020-2021 to assist people most in need of support in Prince Edward Island.

- **Progress update on the 1,200 Affordable Housing Units:** During the period 2018-2023 the government will create over 1,200 new affordable housing units to support households to move out of core housing need. As of February 2021, government initiated 742 affordable housing units, including:
 - o the creation of 600 rent based on income mobile rental vouchers;
 - o the development of 100 new social housing units owned by the Prince Edward Island Housing Corporation, an investment of \$16.9 million; and
 - o the construction of 42 of the Affordable Housing Development Program to incentivize private developers to create affordable units.
- Implemented several initiatives to improve emergency and transitional shelter capacity for Islanders in need including:
 - o reported on progress of the Community Needs Assessment on Emergency Shelters recommendations in June 2020;
 - o purchased the property at 241 Euston Street and opened the Community Outreach Centre;
 - purchased the former Smith Lodge and opened it as transitional housing for persons with multiple, complex needs in December 2020, and
 - in partnership with the Canadian Mental Health Association, completed a "Needs Analysis of Housing Supports in the Prince County Region of Prince Edward Island".
- Announced significant investments in Social Programs: An additional \$7.5 million
 was allocated to increase the AccessAbility Supports Program to enhance benefits and
 supports and increase assistance to Islanders living with disabilities including physical,
 intellectual, neurological, sensory and mental disabilities.
- New funding model and expansion of facilities for community-based residential service providers: The department invested \$1 million into a new funding model to provide consistent funding to non-government organizations (NGOs) providing residential supports. Additionally, \$1.6 million was invested to assist residential NGOs to expand their facilities and support services.

- Implementation of a provincial 211 service: Staff coordinated Government's work with the United Way to implement a 211 service in Prince Edward Island. During the first year of operation, 211 supported approximately 31,600 Islanders though the multiplatform navigation services, with 3,200 callers being provided with 3,600 referrals. During the COVID-19 pandemic response, 211 PEI was a critical service to Islanders.
- Launch of a secure income pilot: In order to examine workable solutions to address poverty challenges experienced by some PEI residents, this pilot program provides financial assistance up to (80%) of Market Basket Measure (MBM) to people with severe limitations to entering the workforce. The pilot program is designed as a basic income model for vulnerable populations and is means tested. As of March 31, 2021, there were 100 clients in the program. The 2020-21 budget provided an additional \$2.3 million in funding to expand this pilot program.
- Responses to COVID-19: The pandemic responses included temporary moratoriums on evictions on provincially owned social housing and providing \$1.5 million in new funding for Temporary Rental Assistance Benefits. The Department ensured day-to-day operations remained consistent to deliver payments and services for Islanders in need.
- Foster Care Review 2019: This comprehensive review facilitated by a committee including: departmental staff, foster families and representatives from First Nations identified 32 recommendations. As of March 31, 2021, seven recommendations were implemented, including a compensation review resulting in increased funding to foster parents effective March 1, 2021.
- Seniors Independence Initiative: During the year, a review was undertaken to enhance the program to better address the needs of Island seniors. As a result of this review several changes were implemented including:
 - o increasing the income thresholds and benefit caps;
 - o improving access to services with more flexibility for seniors; and
 - o including family members as eligible service providers as long as they don't live in the same household.




