# SUBDIVISON AND DEVELOPMENT REGULATIONS AMENDMENT

Pursuant to clause 8(1)(i) of the *Planning Act* R.S.P.E.I. 1988 Cap. P-8, Council made the following regulations:

- 1. Section 65 of the *Planning Act* Subdivision and Development Regulations (EC693/00) is amended
  - (a) by the deletion of the period at the end of subclause (c)(i) and the substitution of a semicolon; and
  - (b) by the addition of the following after subclause (c)(i):
    - (ii) a portion of the road known as the Hackeney Road or the John Joe Road in the settlement of Mill River, commencing at a point 0.12 miles (0.2 km) from the intersection of Route 136 to the intersection of Route 142, a distance of approximately 1.42 miles (2.3 km).
- 2. The regulations are amended by the addition of the following after section 65:
- **65.1** Notwithstanding clause 1(s.2), "scenic heritage road" for the "scenic heritage purposes of subclause 65(c)(ii) means the verge, ditch and land within the road boundaries of the Hackeney Road.
- 3. These regulations come into force on August 28, 2004
