PRINCE EDWARD ISLAND LANDS PROTECTION ACT PETITION TO ACQUIRE A LAND HOLDING DOVER FISH HATCHERY LTD. (APPROVAL)

Pursuant to section 5 and section 9 of the Prince Edward Island Lands Protection Act R.S.P.E.I. 1988, Cap. L-5 Council granted permission to Dover Fish Hatchery Ltd. of Murray River, Prince Edward Island to acquire a land holding of approximately one hundred (100) acres of land at Glenwilliam, Lot 63, Kings County, Province of Prince Edward Island, being acquired from Donald Colin Stewart and Mae I. Stewart, both of Murray River, Prince Edward Island. Council noted that two parcels totalling approximately thirty-one decimal four five (31.45) acres have been subdivided from the parent parcel and conveyed to others; these are now known as Provincial Property Nos. 902726 (10.07 acres) and 863845 (21.38 acres). Approval is SUBJECT TO (i) the partly adjacent land holding of approximately twenty-six decimal nine five (26.95) acres (formerly part of Provincial Parcel Property No. 288506) being consolidated with the remaining land holding of approximately sixty-eight decimal five five (68.55) acres (Provincial Property No. 260471) and (ii) the resulting consolidated parcel of approximately ninety-five decimal five (95.5) acres being subject to a condition preventing subdivision. The condition preventing subdivision shall be binding on the said Dover Fish Hatchery Ltd. and on all successors in title.

# ROADS ACT HIGHWAY ACCESS REGULATIONS AMENDMENT

Pursuant to subsection 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

- 1. Clause 1(3)(i) of Schedule A-3, INFILLING AREAS, of the *Roads Act* Highway Access Regulations (EC580/95) is revoked and the following substituted:
  - (i) in the Community of St. Peters, that segment of highway that lies between Anderson Road and the eastern boundary of the Community; and
- 2. These regulations come into force on June 14, 2014.

### **EXPLANATORY NOTES**

**SECTION 1** amends a provision of the Highway Access Regulations to extend for infilling the portion of arterial highway referenced in the provision.

**SECTION 2** provides for the commencement of these regulations.
