ARCHIVES AND RECORDS ACT REGULATIONS

Pursuant to section 20 of the Archives and Records Act R.S.P.E.I. 1988, Cap. A-19.1, the Lieutenant Governor in Council made the following regulations:

1. In these regulations

Definitions

- (a) "Act" means the Archives and Records Act R.S.P.E.I. 1988, Cap. Act A-19.1;
- (b) "English Language School Board" means the English Language English Language School Board School Act R S P F I 1988 Cap School Board School Board established under the *School Act R.S.P.E.I.* 1988, Cap. S-2.1;

(c) "French Language School Board" means the French Language French Language School Board (La Commission scolaire de langue française) School Board continued under the School Act;

- (d) "Health PEI" means Health PEI established under the Health Health PEI Services Act R.S.P.E.I. 1988, Cap. H-1.6.
- 2. Each of the following is designated as a public body for the purposes Designation as of the Act:
 - public body

- (a) English Language School Board;
- (b) French Language School Board;
- (c) Health PEI.
- **3.** These regulations come into force on October 17, 2015.

Commencement

EXPLANATORY NOTES

SECTION 1 defines terms used in these regulations.

SECTION 2 designates the English Language School Board, the French Language School Board and Health PEI as public bodies for the purposes of the Act, pursuant to subclause 20(c)(iii) of the Act.

SECTION 3 provides for the commencement of these regulations.

ENVIRONMENTAL PROTECTION ACT EXCAVATION PITS REGULATIONS AMENDMENT

Pursuant to section 25 of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, Council made the following regulations:

- 1. Subsection 4(4) of the *Environmental Protection Act* Excavation Pits Regulations (EC753/90) is amended by the deletion of the words "clauses (1)(d)," and the substitution of the words "clauses (1)(d), (d.1),".
- 2. These regulations come into force on October 17, 2015.

EXPLANATORY NOTES

SECTION 1 amends subsection 4(4) of the regulations to add clause 4(1)(d.1) to the provisions the Minister may decide to waive in order to issue a permit for a pit for a period not to exceed 6 months. Clause 4(1)(d.1) applies where any part of a pit is within 500 metres of a church, school, hospital or other specified public place.

SECTION 2 provides for the commencement of the regulations.

ENVIRONMENTAL PROTECTION ACT MATERIALS STEWARDSHIP AND RECYCLING REGULATIONS AMENDMENT

Pursuant to section 25 of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, Council made the following regulations:

- 1. Section 59 of the *Environmental Protection Act* Materials Stewardship and Recycling Regulations (EC349/14) is amended
 - (a) by the addition of the following after clause (d):
 - (d.1) "glycol product" includes a container with a capacity of up to glycol product 50 litres manufactured for the purpose of holding glycol;
 - (b) by the addition of the following after clause (f):
 - (f.1) "oil product" includes a container with a capacity of up to 50 oil product litres manufactured for the purpose of holding an oil product and includes aerosol containers as well as aerosol containers used to contain products used as brake cleaner;
- 2. Subsection 63(3) of the regulations is amended by the deletion of the words "oil, oil filters or glycol products" wherever they occur and the substitution of the words "oil products, oil filters, or glycol products".
- 3. These regulations come into force on October 17, 2015.

EXPLANATORY NOTES

SECTION 1 clarifies that oil and glycol containers, as well as aerosol containers for brake cleaner, are included within the regulations.

SECTION 2 remedies a terminological inconsistency in subsection 63(3) and brings it in line with the phrase used in the rest of Division 4.

SECTION 3 provides for the commencement of these regulations.

AN ACT TO AMEND THE MARITIME PROVINCES HARNESS RACING COMMISSION ACT DECLARATION RE
