PRINCE EDWARD ISLAND LANDS PROTECTION ACT PROPERTY NO. 677930, LOT 5, PRINCE COUNTY IDENTIFICATION FOR NON-DEVELOPMENT USE **AMENDMENT**

Pursuant to subsection 9(2) of the Prince Edward Island Lands Protection Act R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately forty-five decimal zero four (45.04) acres of land, being Provincial Property No. 677930 located at Bloomfield Corner, Lot 5, Prince County, Prince Edward Island and currently owned by Ramsay Farms Ltd. of Alberton, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately two (2) acres SUBJECT TO the subdivided parcel being consolidated with the adjacent Provincial Property No. 935700 concurrently at the time of the subdivision. Further, Council determined that following subdivision, identification for non-development use shall continue to apply to the remaining land.

PUBLIC INQUIRIES ACT AND ARCHIVES AND RECORDS ACT (NATIONAL INQUIRY INTO MISSING AND MURDERED INDIGENOUS WOMEN AND GIRLS)

WHEREAS by Order-in-Council EC2016-611 of September 13, 2016, the Lieutenant Governor in Council pursuant to section 2 of the *Public Inquiries Act*, R.S.P.E.I. 1988, Cap. P-31 appointed commissioners to conduct an inquiry as part of the National Inquiry into Missing and Murdered Indigenous Women and Girls (the "Commission").

AND WHEREAS the Order-in-Council provided that the Commission was to simultaneously deliver its final report to the Governments of Canada and Prince Edward Island before November 1, 2018.

AND WHEREAS the Governor General in Council amended its order to extend the date for delivery of the final report to April 30, 2019, by Order-in-Council 2018-0686 of June 6, 2018.

AND WHEREAS the Commission is a public body within the meaning of the *Archives and Records Act*, R.S.P.E.I. 1988, Cap. A-19.1 and, therefore, its record would be a public record which, absent direction from Council, would have to be held in the care and control of the Provincial Archivist once the Commission ceases to function.

AND WHEREAS it is desirable that the Commission's record, as the public record of a national inquiry, be held by Library and Archives Canada in Ottawa,

THEREFORE, Council directs that the Commission issued pursuant to Order-in-Council EC2016-611 of September 13, 2016 be amended by:

- (a) replacing "November 1, 2018" with April 30, 2019 in subparagraph 9(b); and
- (b) adding, as paragraph 11, the following:
 "Pursuant to section 10 of the *Archives and Records Act*, R.S.P.E.I. 1988,
 Cap. A-19.1, Council directs that the Provincial Archivist shall not be
 required to have care and control of the public record of the Commission
 provided that the public record is to be transferred to Library and Archives
 Canada when the Commission ceases to function."
