# **ELECTION ACT**

# TARIFF OF FEES AND EXPENSES REGULATIONS AMENDMENT

Pursuant to section 120 of the *Election Act* R.S.P.E.I. 1988, Cap. E-1.1, Council made the following regulations:

- 1. Clause 6(b) of the Schedule to the *Election Act* Tariff of Fees and Expenses Regulations (EC645/07) is amended by the deletion of the words "\$175" and the substitution of the words "\$500".
- 2. These regulations come into force on October 22, 2022.

## **EXPLANATORY NOTES**

**SECTION 1** amends clause 6(b) of the Schedule to the Tariff of Fees and Expenses Regulations (EC645/07) to raise the maximum amount of rent per day that may be paid for an advance polling station for each electoral district from \$175 to \$500.

**SECTION 2** provides for the commencement of these regulations.

E-12 Council authorized the Minister of Justice and Public Safety to enter into an agreement with the Province of Nova Scotia, as represented by the Minister of Justice and the Chief Medical Examiner of the Nova Scotia Medical Examiner Service, to provide a formalized framework describing terms and conditions whereby the Chief Medical Examiner for Nova Scotia may provide forensic postmortem examinations; death investigators in relation to an investigation or inquest conducted by a Coroner; and death investigation trainers for the provision of training Field Investigators or Coroners who will provide services under the *Coroners Act*, from the effective date of the agreement for a five (5) year period, such as more particularly described in the draft agreement.

ISLAND INVESTMENT DEVELOPMENT ACT FINANCIAL ASSISTANCE REGULATIONS ABBOTT LANGILLE HOLDINGS INC. AUTHORIZATION

Pursuant to subsection 2(3) of the *Island Investment Development Act* Financial Assistance Regulations (EC2005-686), Council authorized Island Investment Development Inc. to provide a ten-year term loan in the amount of four million (\$4,000,000.00) dollars at a rate of four (4%) percent to Abbott Langille Holdings Inc. for the purchase of capital assets, on terms and conditions satisfactory to the Board of Directors of Island Investment Development Inc.

# PROVINCIAL COURT ACT JUSTICE OF THE PEACE APPOINTMENT

Under authority of section 14 of the *Provincial Court Act* R.S.P.E.I. 1988, Cap. P-25 Council appointed Kendra Jeanise Smith of Summerside as a Justice of the Peace in and for the Province of Prince Edward Island for a term of five (5) years, effective October 11, 2022.

Further, Council ordered that should Kendra Jeanise Smith cease to be employed by the Province of Prince Edward Island in her present capacity in the Department of Justice and Public Safety, her appointment as Justice of the Peace shall terminate coincident with the date the employment terminates.
