## Department of Health and Wellness Overview

The Prince Edward Island Department of Health and Wellness serves and supports all Islanders. In accordance with the *Health Services Act*, the Department supports the Minister of Health and Wellness in providing oversight of health services in the province and establishing accountability mechanisms, standards for health services, performance targets, and policies and guidelines for the management and delivery of services. It also provides leadership in matters related to public health and health promotion and establishes policy direction to improve the health and well-being of citizens of PEI. It works to ensure alignment of priorities between the Department of Health and Wellness and Health PEI, which is critical for ensuring that both organizations work together effectively to create measurable progress on enhancing the health and well-being of Islanders.



## **Mandate**

The mandate of the Department of Health and Wellness is to provide leadership, policy direction and programs that contribute to:

- health protection and promotion for Islanders; and
- quality and sustainable health services that are accessible to Islanders.

The Department fulfils this mandate in partnership with Islanders and communities, Health PEI, health professions and allied health professionals, non-government and community organizations, the private sector, and other government departments.



## **Highlights and Accomplishments**

#### **Expenditures**

• In 2018-2019, the Department of Health and Wellness **operating budget was \$33.2 million**, up from \$12.7 million in 2017-2018 due to the transfer of Emergency Health Services from Health PEI to the Department of Health and Wellness.

### Planning and Policy Development

- The Department of Health and Wellness **added coverage of gender-confirming surgeries** to the province's Medicare program. Improving access to insurable gender-confirming surgeries will help those who are eligible and for whom the surgery is an important part of their gender transition. The province continued to offer counselling, psychotherapy, and hormone therapy through the provincial health care system.
- The Department of Health and Wellness added programs and expanded services to support
  Islanders and enable community-based treatment. These included the Ostomy Supplies
  Program, improving COPD programs and expanding hemodialysis services.
- The Department of Health and Wellness released **Promoting Wellness: Preserving Health: A Provincial Action Plan for Seniors, Near Seniors, and Caregivers.** The action plan laid out four pillars, each with accompanying recommendations to better support Island seniors and their health:
  - o Develop and implement "Home First" age-in-place initiatives;
  - o Incorporate an age-friendly approach to communities, home, workforce, and health care facilities;
  - o Address ageism and support active aging; and
  - o Support upstream endeavors that address the social determinants of health.
- The Gambling Addictions Support Unit also made new **Mental Health Kits and Gambling Support Kits** available at public libraries across the province. Both the Mental Health Kits and Gambling Support Kits offered self-help support and guidance for Islanders and their families.

## Population Health

The PEI Tobacco Reduction Alliance worked with the Chief Public Health Office, Student Well-Being Teams and other educators in order to educate Island youth on the risks associated with vaping. The effort was part of an effort to combat a rise in vaping amongst Island youth, and youth across Canada more generally.

- The Canadian Cancer Society's new *Cooking to Quit* **smoking cessation program** was launched with support by a Wellness Grant from the Department. The program provided people with training in cooking and nutrition to ease the discomfort associated with quitting smoking. The program was offered in conjunction with dieticians from Sobeys grocery stores, and gave participants access to certified tobacco educators to provide guidance and support to people in their efforts to quit smoking.
- The Department's 2018-19 budget included approximately **\$2 million to expand the Hepatitis C Drug Program** and hire dedicated resources to support this Program. The increased funding for the program allowed Health PEI to enhance access to curative medication, prevention, and follow-up care. This additional funding was an important step in helping the Government of Prince Edward Island reach its goal of eliminating Hepatitis C from the province by 2025.
- The provincial government introduced **new monthly walk-in clinics** in both Summerside and Charlottetown focusing on sexually transmitted infections. The clinics are open after-hours and offer confidential, safe, barrier-free, no-appointment testing for Island residents.
- The **PEI Children's Report 2017** was released in January 2018. This report explores the relationship between the social determinants of health, health equity, healthy behaviours, and health outcomes for Island children. Risk factors to healthy child development, cognitive development and the social environment are considered as well. The report establishes a baseline of key indicators of child health and well-being in PEI and calls us to take action for PEI children.

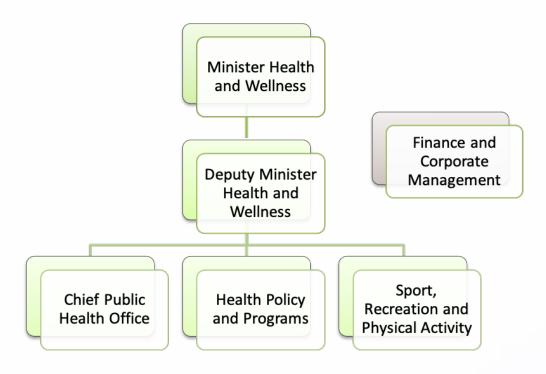
## **Encouraging Healthy and Active Lives**

- The Sport, Recreation and Physical Activity division worked closely with Federal, Provincial and Territorial partners on the release of the *Common Vision for Increasing Physical Activity in Canada* that sets out a pathway and shared vision for the advancement of physical activity in the country. This document, along with the *Canadian Sport Policy* and *Framework for Recreation in Canada*, helps shape priorities such as women and girls in sport, physical literacy programming, encouraging Islanders to explore nature and natural spaces, increasing physical movement, and access to programs and opportunities.
- The Sport, Recreation and Physical Activity division **enabled more Islanders to try different sport and recreation opportunities** through many "come try" events and activities where Islanders got the opportunity to try an activity with little or no cost to see if they enjoy it. Many sport organizations use a similar model to develop their sport in different parts of the province.

- In February of 2019 over **200 Team PEI athletes attended the Canada Winter Games** in Red Deer Alberta where Kristen Arsenault won a silver medal in Archery and Mikey Perry won a bronze in Judo.
- The Province was officially **awarded the 2023 Canada Winter Games** by the Canada Games Council in November 2018. In February of 2018 the 2023 Host Society was officially incorporated.
- In April 2018 the Province entered a three- year funding agreement with the University of Prince Edward Island to **establish a Concussion Awareness Program**. This Program helps support a nationally harmonized approach to concussions, which included five components: awareness, prevention, detection, management and surveillance.

## **Finance and Corporate Management**

This Division supports and assists the Department of Health and Wellness in the areas of human resource management and financial management.

#### **Chief Public Health Office**

Public health is defined as the organized efforts of society to keep people healthy and prevent injury, illness, and premature death. It is the combination of programs, services, and policies that protect and promote health.

The mandate of the Chief Public Health Office (CPHO) is to protect and promote the health of Islanders through leadership, partnership, and excellence in public health. The division is responsible for the delivery of health protection programs including food safety as legislated under the *Public Health Act*. This is accomplished through regulation, inspection, and enforcement. The CPHO is responsible for preventive measures to reduce the spread of diseases including immunization and communicable disease infection control. The CPHO also monitors provincial health trends to help inform program development and public health policy.

### Sport, Recreation and Physical Activity Division

This division encourages Islanders to be active through sport, recreation, and other physical activity. This is achieved through a wide variety of partnerships with sport, recreation, and active living organizations throughout the province. The division provides grants and consultation services to a few provincial, regional, and community groups and works with a variety of provincial and federal government departments and organizations, as well as national and interprovincial non-governmental organizations.

Programs supported by this division include the Amateur Sport Program, the Community Recreation Support Program, and go!PEI.

## **Health Policy and Programs**

This division provides policy and planning support in various aspects of health care delivery. In turn, these supports assist the Minister in providing leadership, strategic direction, and oversight of the health care system. The division is also responsible for health workforce planning through the actions of the Recruitment and Retention Secretariat.
