STUDENT REGULATIONS AMENDMENT

Pursuant to subsection 26(2) and section 107 of the *Education Act* R.S.P.E.I. 1988, Cap. E-.02, Council made the following regulations:

1. The *Education Act* Student Regulations (EC531/16) are amended by the addition of the following after section 6:

INDEPENDENT STUDENTS

6.1 Application for designation as independent student

(1) A student who is 16 years of age or older may apply to the Director, in the form required by the Director, to be designated as an independent student.

Factors

- (2) The Director may designate the student as an independent student where the Director determines that the student is living independently of the parents of the student, after considering relevant factors including
 - (a) the student's living arrangements;
 - (b) the student's financial means and support;
 - (c) the student's responsibility for significant decisions affecting the student;
 - (d) the duration of any independent living or financial arrangements; and
 - (e) any legal proceedings related to parental rights in respect of the student.

Evidence

(3) The Director may consider representations and documentation provided by the student, a parent of the student and any other person who has information relevant to the determination under subsection (2).

Decision

(4) The Director shall give notice in writing to the student and a parent of the student of the Director's decision on the student's application, with reasons, and of the right to appeal the decision under section 55 of the Act.

2. The regulations are amended by the addition of the following heading after section 10:

Appeal

3. (1) Subsections 11(1) and (2) of the regulations are revoked and the following substituted:

11. Notice of appeal

(1) For the purpose of subsection 55(1) or (1.1) of the Act, a parent of a student or a student may file a notice of appeal in writing with the education authority within ten days of receiving notice or otherwise having knowledge of the decision under appeal.

Contents of notice

- (2) The notice of appeal shall include
 - (a) a copy of the notice of decision under appeal or information and any supporting documentation respecting the decision under appeal; and
 - (b) a description of the basis for the appeal.
- (2) Clause 11(3)(b) of the regulations is amended by the deletion of the words "the parent of the student" and the substitution of the words "the appellant".
- (3) Subsection 11(4) of the regulations is amended by the deletion of the words "the parent of the student" and the substitution of the words "a parent of the student, the student".
- 4. Section 12 of the regulations is amended by the deletion of the words "the appeal of a parent of a student" and the substitution of the words "an appeal".
- 5. These regulations come into force on February 14, 2025.

EXPLANATORY NOTES

SECTION 1 adds a new heading and section 6.1 to the regulations to set out an application process for a student to be designated as an independent student.

SECTION 2 adds a new heading to the regulations.

SECTION 3 amends section 11 of the regulations to reflect that a student may appeal a decision to not designate the student as an independent student.

SECTION 4 amends section 12 of the regulations to reflect that a student may appeal a decision to not designate the student as an independent student.

SECTION 5 provides for the commencement of these regulations.
