The City of Charlottetown and efficiencyPEI are collaborating to deliver sustainability programs to assist low-income Islanders. Charlottetown residents will now be able to access efficiencyPEI's Home Energy Low-Income Program and The City of Charlottetown's Low Income Financial and Technical Assistance Program simultaneously. These programs are free of charge and will help low-income Islanders save money on their monthly utility bills through reducing energy and water consumption. This collaboration aims to make the process as simple as possible by providing access to both programs through a single application and appointment.

Why Water Conservation Matters

Many Canadians believe that fresh water is abundant or even unlimited. This is not true. According to Environment and Climate Change Canada, the average Canadian uses 251 litres/ day making us one of the highest water users in the world.

Prince Edward Island is dependent on groundwater for its water source. It is important that we use water carefully and make an effort to cut out our water waste. To continue to be a safe (fire protection, hospitals), healthy, and beautiful (ponds, gardens) community, we need to save for the future.

Research has shown that a meter installed reduces overall water consumption as the customer pays for the water they use. The Low-Income Financial and Technical (LIFT) Assistance Program assists low-income clients to install low-flow devices in the home and provides tips to reduce water consumption.

Small changes can make a difference!

Why Air Sealing Matters

Controling air leakage has many benefits to you and your home:

- · Saving money on heating costs
- · Greater comfort with fewer cold spots and drafts
- Less moisture infiltration to home, protecting building materials from rot
- Quieter home and improved air quality by reducing the amount of noise and dust entering the house

Low-income Financial and Technical (LIFT) Assistance Program

Low-income clients with a total household income of \$50,000 or less, are eligible to have a HELP tradesperson complete a comprehensive residential water audit free of charge.

Other features of the LIFT program include:

- · installation of a low-flow showerhead
- installation of low-flow aerator on bathroom sink
- · check for leaks
- a voucher for low-flow toilet and installation, if applicable*

These are simple measures that can a have a big impact on the amount of water use in your home, saving you money.

* The water audit will determine if you qualify for a rebate for you to purchase a low-flow toilet and have it installed. Toilet rebate will be 50% of the cost (including taxes) of an approved toilet up to \$250 and up to \$100 for installation by licensed plumber with proof of disposal of older toilet. Persons eligible for this rebate may also be eligible for a \$50 rebate under efficiencyPEI.

Home Energy Low-income Program (HELP)

Low-income clients with a total household income of \$50,000 or less, are eligible to have a HELP tradesperson complete a comprehensive air-sealing (caulking, weather-stripping, sealing gaskets, etc....) free of charge.

Other features of the HELP program include:

- installation of a programmable thermostat
- a voucher for a free furnace cleaning (up to \$80 value)
- a quantity of ENERGY STAR® LED light bulbs

These are simple measures that can a have a big impact on the amount of heat lost in your home, saving you money.

The results will vary depending on the size of your home, the current condition of your home and the type of heating system you have—installing a programmable thermostat can save up to \$250 per year in heating costs; and sealing air leaks with caulking and weather-stripping on windows and doors, sealing electrical outlets, and weather-stripping your attic hatch can save as much as \$650 per year in heating costs.
