

HOME INSULATION REBATES

Insulation and air sealing are the most effective ways to prevent heat loss and save energy.

Rebates are available for the installation of insulation, air sealing improvements as well as ENERGY STAR® windows and doors. Upgrades to the shell of a house (known as a building envelope) protects it from the elements and can yield big savings on heating costs.

In addition to rebates, financing is available through the Finance PEI to assist with the up-front costs of insulation upgrades.

Income qualified Islanders may be eligible for free home insulation. Visit the Free Home Insulation Program to check your eligibility.

How do I apply?

To get a home insulation rebate, follow these steps:

1. Contact an efficiencyPEI partner to complete an EnerGuide Rating System home energy assessment.
2. Confirm eligibility by reviewing the rebate guide on this brochure and complete your upgrades.
3. Contact your efficiencyPEI partner for a follow-up audit. The auditor will collect your paperwork and submit it to efficiencyPEI on your behalf.

Why do I need a home energy assessment?

The home energy assessment is a mandatory part of the program. It provides useful information about your home's energy performance that will help you make informed, decisions when operating, renovating or purchasing a home. Choosing the right upgrades will save the most energy and be the most effective at lowering your monthly costs.

The home energy assessment is offered at a subsidized rate of \$99 plus HST.

Where can I find a list of contractors that install insulation?

You can search the Network of Excellence for contractors that install insulation. You can search for a contractor by name or by the service they provide or you can view a list of contractors by county, or by program, by selecting an option from the "County" and "Program" fields. What are the rebate amounts?

Rebates are different for different types of upgrades.

Insulation rebates are calculated based on the amount of insulation you install; the more insulation you install the bigger the rebate and the more energy you save!

For example, if you were to insulate a 28' x 42' (28' x 42' = 1176 square feet or 11.76 SQ) attic from an existing level of R20 to R50 (an increase of R30) the rebate would be; $\$3.50 \times 11.76 \text{ SQ} \times R30 = \$1,234.80$

Other rebates are listed in the table below:
