- (a) Under this section of your Policy, you agree that we will not pay more than the actual cash value at the time the loss or damage occurs or \$\_\_\_\_\_\_\_, whichever is less, for loss of or damage to the contents of the described motorhome or vacation trailer under Section A.1 (Direct Compensation Property Damage) and C (Loss of or Damage to Insured Automobile) as stated above. This coverage is subject to the deductible shown above;
- (b) The perils for which indemnity for loss of or damage to the motorhome or vacation trailer is provided in this endorsement shall be the perils as are stated above.

If more than one motorhome or vacation trailer is insured under this Policy, this endorsement shall apply only to the motorhome or vacation trailer against which the PE – S.E.F. No. 62 is designated in the schedule of automobiles forming part of this Policy.

Except as otherwise provided in this endorsement, all limits, terms, conditions, provisions, definitions, and exclusions of the Policy shall have full force and effect.
