COMMUNITY CONVERSATIONS

The Public Engagement Process

The Public Engagement Process consists of:

- 2 Surveys public and service providers
- 11 Small Group Conversations invite only
- 6 Community Conversations open to public

Public Surveys

- 1075 Islanders completed the public survey
- 40% have a yearly household income of less than \$50,000
- 47% one income families
- 40% have mental health issues
- 28% have a disability

Public Surveys

- 27% single parent families
- 13% on social assistance
- 9% from the LGBTQ2 community
- 5% Indigenous
- 3% new immigrants

Service Provider Surveys

- 50 in total
- All work with one or more of these populations:
 - People on social assistance
 - Women
 - Families
 - People with mental health issues
 - Single parents
 - Seniors
 - People dealing with homelessness
 - People with addiction issues
 - People looking for employment
 - People with disabilities

Small Group Conversations

 11 small group conversations were held with 170 service providers/people lived experience:

People on Social Assistance	Low income/seasonal workers
Seniors	Newcomers and immigrants
General service providers (2)	Women
People with disabilities	Indigenous people off reserve
Indigenous people on reserve	Youth

Public Community Conversations

6 community conversations open to the public

Preliminary Findings

Barriers/Challenges/Issues that contribute to poverty:

- Housing costs/options
- Wage rates/minimum wage
- Social assistance, pension and El rates
- Food and utility costs e.g. heat, electricity, etc.
- Childcare costs and availability
- Difficulties navigating the system/accessing services

Preliminary Findings

- Cost of health services and supports e.g. prescription drugs, eye glasses, dental care, etc.
- Government support and service criteria e.g. need to make below a certain amount to qualify
- Cost of transportation/limited public transportation
- Limited job opportunities seasonal jobs/limited work hours
- Cost of continuing education

Preliminary Findings

Top 5 areas that Islanders want the Action Plan to focus on:

- Housing
- Employment and wages
- Food security
- Social services and supports
- Health services

Preliminary Findings: Suggestions for action

Housing

- More low income housing that is safe and well maintained
- Rent rates based on income 25% of total income

Preliminary Findings: Suggestions for action

Employment and Wages

- Higher minimum wage
- Basic Guaranteed Income
- Revise EI and social assistance systems to support attachment to the workforce
- Help with continuing education and career training
- Support for small businesses/enterprises
- Life skills training in schools and through employment programs – e.g. budgeting, healthy cooking, etc.
- Fair taxes

Preliminary Findings: Suggestions for action

Food Security/Social Services and Supports/Health Services

- Increase social assistance rates and ceilings for food, utilities, etc.
- Increase pension rates e.g. seniors, disability, etc.
- Universal/subsidized drug care, eye care and dental care
- Transportation supports
- Better coordinated services one-stop-shop so services are easier to access and navigate
- Long-term planning and government commitment to policy and system changes
