1.0 PURPOSE

1.1 To describe the process to seek approval to keep a service animal in seniors housing.

2.0 **DEFINITIONS**

2.1 **Service Animal:** an animal that is individually trained to do work, or perform tasks, for the benefit of an individual with a disability, including a physical, sensory, psychiatric, or intellectual disability. Service animals must be trained by an accredited facility.

3.0 POLICY STATEMENT

- 3.1 Service animals are permitted in all seniors housing buildings. Tenants with service animals must provide proof of accredited training.
- 3.2 People who require a service animal must make this information known when applying for seniors housing.
- 3.3 Tenants who require a service animal during their tenancy must obtain approval from Housing Services prior to bringing the service animal into seniors housing.
- 3.4 Tenants with service animals are required to follow the relevant policies.

4.0 PROCEDURE STATEMENT

- 4.1 Tenants or prospective tenants must complete the *Pets, Dogs, and Service Animals in Seniors Housing Application Form* and submit it to Housing Services.
- 4.2 Housing Services shall meet with tenants or prospective tenants wishing to keep a service animal, review the relevant policies, and answer any questions.
- 4.3 Housing Services shall provide written notice to prospective or current tenants as to whether their application to keep a service animal has been approved or denied.
- 4.4 A Pets, Dogs, and Service Animals in Seniors Housing Addendum is completed with the tenant upon approval to keep a service animal in seniors housing. Housing Services shall provide the tenant with a copy of the signed addendum and retain a copy for the tenant's file.
- 4.5 If approval is received to keep a service animal, subsequent tenant reviews will reflect the addition of the service animal.
