AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 27 February 2001.)

Pursuant to section 65 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

1. Subsection 5(3) of the *Highway Traffic Act* Fees Regulations (EC309/93) is revoked and the following substituted:

(3) The annual registration period for vehicles registered under the International Registration Plan (IRP) is set in accordance with the registration year of the plate jurisdiction.

2. Section 9 of the regulations is revoked and the following substituted:

9. The administrative charges for services and documents set out in column 1 of Table 5 are as set out in column 2 thereof. Administrative charges
