AND WHEREAS the Arms for this said Province by virtue of the said Royal Warrant are “Argent on an island Vert, to the sinister an oak tree fructed, to the dexter thereof three oak saplings sprouting all proper, on a chief Gules a lion passant guardant Or” as is recorded in the College of Arms of England, together with the Motto PARVA SUB INGENTI, meaning “The small under the protection of the great”;

AND WHEREAS Premier Patrick G. Binns did on the fourth day of April 2001 represent to Her Excellency the Right Honourable Adrienne Clarkson, Governor General of Canada, his wish and that of the Executive Council of Prince Edward Island that the Arms of the Province be augmented with a Crest and Supporters;

AND WHEREAS Her Excellency the Governor General has been pleased to grant by Viceregal Warrant the Augmentation to the Arms of the PROVINCE OF PRINCE EDWARD ISLAND, and the Chief Herald of Canada has recorded this Augmentation in Volume IV, page 195 of the Public Register of Arms, Flags and Badges of Canada;

AND WHEREAS it is deemed desirable and in the public interest that details of the Augmentation of the said Arms of Our Province of Prince Edward Island be proclaimed;

AND FOR SUPPORTERS: Two foxes (*Vulpes fulva*) Sable embellished Argent, that to the dexter gorged with a collar of potato blossoms proper, that to the sinister gorged with a length of fishnet Argent, both on a mount Vert set with a Mi'kmaq star Azure between lady's slipper flowers (*Cypripedium acaule*), red roses, thistles, shamrocks and white lilies proper;

AND KNOW YE that We do also by these Presents proclaim the immediate taking into use of the augmented Armorial Achievement for the PROVINCE OF PRINCE EDWARD ISLAND as hereinbefore described, all of which Presents Our Loving Subjects of Our said Province, and all others whom they may concern, are hereby requested to take notice and govern themselves accordingly;

IN TESTIMONY WHEREOF We have caused the Great Seal of Our Province of Prince Edward Island to be hereunto affixed;

WITNESS: His Honour Our right trusty and well-beloved J. Léonce Bernard, Lieutenant Governor of Our Province of Prince Edward Island;

GIVEN at Our Province House in the City of Charlottetown in Our said Province this thirteenth day of December in the year of Our Lord two thousand and two and in the fifty-first year of Our Reign.
