

Pursuant to Subsection 12(1) of the Municipalities Act R.S.P.E.I. 1988, Cap M-13, the Town of Kensington has applied to the Minister of Communities, Cultural Affairs and Labour to extend the Town's municipal boundary to include parcel number 880880 with approximately 45.32 acres and parcel number 80986 with approximately 0.81 acres as outlined below:



The application states that the reasons for the expansion are:

The Town of Kensington has applied to bring two adjoining properties into the Town's boundaries. The land, bordering Sunset Drive and the Old Summerside Road on the west side of the Town of Kensington, has been purchased to develop a community care facility. Residential housing is being considered for the remaining acreage.

PUBLIC HEARING

In accordance with Section 13 of the Municipalities Act, the Island Regulatory and Appeals Commission has been directed by the Minister of Communities, Cultural Affairs and Labour to conduct a public hearing in or near the area to be annexed for the purpose of reviewing the application.
