ANIMAL HEALTH AND PROTECTION ACT BEE HEALTH REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated 1 April 2008.)

Pursuant to sections 4 and 20 of the *Animal Health and Protection Act* R.S.P.E.I. 1988, Cap. A-11.1, Council made the following regulations:

- 1. Clause 1(1)(f.1) of the *Animal Health and Protection Act*, Bee Health Regulations (EC271/01) is amended by the deletion of the words "egg or sperm" and the substitution of the words "egg, sperm or capped queen cell".
- 2. These regulations come into force on April 12, 2008.

EXPLANATORY NOTES

SECTION 1 amends the definition of "genetic material" to include a "capped queen cell". This amendment will allow the importation into the Province of capped queen cells.

SECTION 2 provides for the commencement of these regulations.
