#### **Trails Officers**

Pursuant to section 5.1 of the *Trails Act* R.S.P.E.I. 1988, Cap. T-4.1, the Minister of Tourism designates the following persons as trails officers for the purpose of enforcing the provisions of the *Trails Act* and *Trails Act* General Regulations (EC760/03):

#### FRANK DOLAN

The restrictions and conditions of these designations are limited to the enforcement of offences outlined in the *Trails Act* and General Regulations.

The Minister of Tourism orders that should any aforementioned person cease to be a volunteer with:

#### Prince Edward Island Trails Inc.

his or her designation as a Trails Officer shall terminate coincident with the date the volunteer affiliation with Prince Edward Island Trails Inc. ceases.

A trials officer does not have the power to search or arrest and is not permitted to carry firearms or other restricted or prohibited weapons as defined in section 2 and subsections 84 (1) and (2) of the *Criminal Code* R.S.C. 1985, Chap. C-46. A trails officer may issue tickets under the *Summary Proceedings Act* R.S.P.E.I. 1988, S-9 in respect of a contravention of the *Trails Act* or General Regulations.

The designations contained herein do not otherwise have an impact on the powers and duties of duly qualified and appointed police officers and police constables who comprise the Prince Edward Island Provincial Police.
