# SUPREME COURT ACT RULES OF CIVIL PROCEDURE AMENDMENTS TO THE 1996 CONSOLIDATION AND PUBLICATION MANNER DETERMINED

Under authority of subsection 25(1) of the *Supreme Court Act*, R.S.P.E.I. 1988, Cap. S-10 Council approved an amendment to the 1996 Consolidated Version of the Rules of Civil Procedure to add Rule 1.08, said amendment having been made by the Rules Committee at its meeting of October 28, 2008, to come into force on January 1, 2009.

Further, under authority of subsection 25(2) of the said Act, Council determined that publication of a Notice in the Royal Gazette shall be deemed to be publication of the said amendment to the 1996 Consolidated Version of the Rules of Civil Procedure and that no further publication relating to the said amendment shall be necessary.

TO ALL TO WHOM these presents shall come or whom the same may in any wise concern:

#### GREETING A PROCLAMATION

WHEREAS in and by section 74 of Chapter 20 of the Acts passed by the Legislature of Prince Edward Island in the 2nd Session thereof held in the year 2008 and in the fifty-seventh year of Our Reign intituled "Judicature Act" it is enacted as follows:

"This Act comes into force on a date that may be fixed by proclamation of the Lieutenant Governor in Council.",

AND WHEREAS it is deemed expedient that the said Act, Stats. P.E.I. 2008, 2nd Session, c. 20 should come into force on the 1st day of January, 2009,

NOW KNOW YE that We, by and with the advice and consent of our Executive Council for Prince Edward Island, do by this Our Proclamation ORDER AND DECLARE that the said Act being the "Judicature Act" passed in the fifty-seventh year of Our Reign shall come into force on the 1st day of January, two thousand and nine of which all persons concerned are to take notice and govern themselves accordingly.

IN TESTIMONY WHEREOF We have caused these Our Letters to be made Patent and the Great Seal of Prince Edward Island to be hereunto affixed.

WITNESS the Honourable Barbara A. Hagerman, Lieutenant Governor of the Province of Prince Edward Island, at Charlottetown this second day of December in the year of Our Lord two thousand and eight and in the fifty-seventh year of Our Reign.
