Application

 This Order provides for the establishment of bulk milk transportation rates for all raw milk transported directly by a transporter from a producer's farm to a designated dairy manufacturing plant.

Definitions

- 2. The words herein shall have the meanings as found in the *Prince Edward Island Natural Products Marketing Act* and the Dairy Farmers of Prince Edward Island Regulations unless differentiated herein and as hereinafter defined:
 - (a) "bulk haulage transportation formula" means the formula used by the Board to determine a transporter's weighted average transport rate using the cost elements described in Appendix "A";
 - (b) "dairy manufacturing plant" means a place where milk or cream is manufactured and processed into Class 1 or industrial milk products;
 - (c) "milk" means the normal milk from cows;
 - (d) "primary transportation" means bulk transportation of raw milk directly from a producer's farm to a dairy manufacturing plant;
 - (e) "primary transportation rate" means the bulk haulage transportation rate established for a transporter by the Board based on an individual transporter's weighted average rate to transport milk from producer's farms to dairy manufacturing plants; and
 - (f) "transporter" means a bulk milk transportation company approved by the Board to transport bulk milk from producer's farms to dairy manufacturing plants.

Establishment of Rates 3.

3. The Board shall establish a bulk milk haulage transportation rate using the formula established in 2(a) and these calculations shall be updated using the bulk milk haulage transportation formula at least once per annum and on the first of a month if there is a change of + or - 4% in the ultra low sulfur diesel fuel price. Transporters will be notified of changes in the transport rates as soon as the rates have been calculated by the Board.

Additional Kilometers

4. Where a transporter is required to deliver milk to a dairy manufacturing plant other than the one designated for a route or to travel additional kilometers to deliver milk to a second dairy manufacturing plant, compensation for the extra distance travelled shall be based on a rate per kilometer determined by the Board using the bulk haulage transportation formula.

Special Pickups

5. The Board may, from time to time, determine a minimum charge in the event that a transporter is required to make a special trip to pick up bulk milk from a producer's farm for delivery to a dairy manufacturing plant. Transporting of milk

No person shall transport milk at a rate or rates other than the rates determined by the Board.

Commencement

7. This order comes into force on the 1st day of August 2009.

Dealer Licensing Order

- Application 1. This order applies to the control and regulation of potato dealers in Prince Edward Island.
- Definitions 2. In this order
 - 1. "Act" means the Natural Products Marketing Act R.S.P.E.I. 1988, Cap. N-3;
 - 2."Board" means the Prince Edward Island Potato Board established pursuant to the Act;
 - 3. "Consumer" means a person who purchases potatoes for personal consumption by that person or his family;
 - 4. "Dealer" means a person who, on his own behalf or as an agent for or on behalf of any other person, is engaged in the marketing of potatoes in Canada and the United States, including Puerto Rico;
 - 5. "Dispute Resolution Corporation" means the Fruit and Vegetable Dispute Resolution Corporation established in 1999 pursuant to Article 707 of the North American Free Trade Agreement;
 - 6."Marketing" means buying, selling or offering for sale, and includes storing, packing, shipping, and transporting in any manner by any person;
 - (g)"Person" includes individual, cooperative, partnership, or corporation;
 - (h)"Plan" means any plan established for the marketing of potatoes established and

amended from time to time pursuant to the Act;

- (i)"Potatoes" means potatoes produced in the Province of Prince Edward Island;
- (j)"Producer" means a person who, in Prince Edward Island, grows potatoes on his own land or on land owned by others;
- (k) "Responsibly connected person" includes individual owners, partners, members, officers, directors or holders of more than 10% of the outstanding stock of a business, and any individuals who function in an executive or managerial capacity; and
- "Transfer" includes any sale of shares of a corporation which results in a change of control of the corporation.

Licensing

- 3.(1) No dealer shall engage in the marketing of potatoes without a license from the Board.
- (2) The maximum number of dealer licenses issued by the Board annually shall not exceed 53 licenses.
- (3) Subsection 3.(1) does not apply to any producer who sells his own potatoes directly to a consumer in Prince Edward Island.

Fees

- 4.(1) The license fee payable to the Board by all dealers engaged in the marketing of potatoes shall be \$ 1,400 plus applicable taxes annually and such license shall be issued to a dealer only on the dealer agreeing to the terms and conditions as set forth in the application for the license.
- (2) Applicants applying for a dealer's license shall consent to a credit inquiry to be carried out by the Board. The Board shall have the right to deny the issuance of a dealer's license to any applicant for whom an unsatisfactory credit report is received.
- (3) Applicants applying for a dealer's license shall provide to the Board written confirmation from the applicant's financial institution indicating that the applicant has established a line of credit for a minimum of \$100,000.

Collection and remittance of levies

5. Each dealer engaged in the marketing of potatoes in Prince Edward Island shall pay a charge to the Board of three cents per hundredweight for potatoes shipped by the dealer based on each transportation number issued by the Board. In addition, each dealer shall collect and remit to the Board the prescribed producer levies for such shipments as set out in Board Order 06-1 (Levies Order) as amended or substituted from time to time.

Application deadline

 Applications for dealer licenses must be received by the Board by no later than July 31st of each year.

License issuance

- 7.(1) Licenses shall be issued by the Board annually on August 1st of each year.
 - (2) If the holder of a dealer license for the preceding crop year fails to apply for renewal of the license for the current crop year, the Board may issue, for each dealer license which was not renewed, a dealer license to a qualified applicant who meets the criteria for issuance of a dealer license, but who did not hold a dealer license in the preceding crop year.
 - (3) If the Board receives more qualified applications for dealer licenses than are licenses

available for issuance pursuant to sub-section 7(2), the license or licenses to be issued shall be determined by random draw conducted by the Board's auditors.

(4) No person shall be issued a license unless that person is a member in good standing in the Dispute Resolution Corporation, and the license of that person shall be suspended immediately by the Board if the person's membership in the Dispute Resolution Corporation is suspended, cancelled, or terminated for any reason.

Violation

8. If a licensed dealer, or any other entity in which a responsibly connected person of the licensed dealer has an interest, is found to have violated any provision of a plan or any order or regulation of the Board, the licensed dealer shall be liable to have his license suspended or canceled forthwith.

Transfer of license

9. No dealer license may be the subject of a transfer to another person without the prior written approval of the Board.

Expirv

10.All licenses shall expire on the 31st day of July in each year.

Renewal

11. Any dealer who is in arrears with the Board with respect to any levies, in addition to any other penalty therefor, shall not be entitled to a renewal of any license required by any licensing order in force from time to time until such time as all arrears of levies are paid to the Board.

Implied term

12. The following provision shall be deemed to be included in any written or oral contract between a PEI potato producer and licensed PEI Potato Dealer for the purchase of potatoes: "Any dispute, controversy or claim arising out of this contract may, at the grower's request, be submitted to, and finally settled by, arbitration administered by the Fruit and Vegetable Dispute Resolution Corporation in accordance with its published rules and procedures. Judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof."

Details of sale to be furnished to Board

- 13.(1) All dealers shall, within a period of twenty-four hours of finalizing a sale of potatoes from the Province of Prince Edward Island, be required to furnish the Board with the name of the buyer; the destination for such shipment; the quantity and size of package; the price; and the mode of transportation, and shall be required before making such shipment to obtain a transportation number from the Board and furnish to the Board the invoice covering such shipment within a period of thirty days from the date of shipment.
 - (2) Each shipment referred to in subsection 13.(1) shall be evidenced by separate invoice, and no invoices purporting to cover more than one shipment shall be accepted by the Board as compliance with the requirements of subsection 13.(1).

Unsatisfied judgments 14.(1)In the event an unsatisfied judgment is registered against an applicant for a dealer's license, or against any other entity in which a responsibly connected person of the applicant has an interest, the Board shall be entitled to refuse to issue a dealer's license to such applicant until all such judgments are paid and satisfied. In addition, it shall be a term and condition of each dealer's license issued by the Board that, in the event that any judgment be registered against a licensed dealer in Prince Edward Island, or against any other entity in which a responsibly connected person of the dealer has an interest, and remain unsatisfied for a period greater than seven days, the license of such dealer shall be liable to suspension or cancellation at the discretion of the Board.

Conflicting information

(2) In the event that information relating to sale of Prince Edward Island potatoes provided by a dealer to the Board orally, in order to obtain a Board transportation order number, varies from information contained in the invoice respecting such sale forwarded to the Board, the Board may, at its discretion, withhold the issuance of further Board transportation order numbers to such dealer until such time as the dealer has an explanation acceptable to the Board for such variance.

Failure to provide (3) invoices

(3) In the event that a dealer declines or fails to provide to the Board a copy of the invoice in respect to any sale of Prince Edward Island potatoes within thirty days of receipt by such dealer of a Board transportation order number in respect to such sale, the Board may, in its discretion, withhold the issuance of further Board transportation order numbers to such dealer until such time as the dealer has made an explanation acceptable to the Board for the refusal or failure to provide such invoice in the time stipulated.

Power to withhold

15. The Board hereby delegates to such of its employees who, in the ordinary course of their duties as employees of the Board issue Board transportation order numbers, the power to withhold Board transportation order numbers to a dealer who is in arrears of remittance of levies to the Board, against whom an unsatisfied judgment in Prince Edward Island exists, or who is otherwise in violation of any Plan, order or regulation of the Board, including subsections 14.(2) and (3) above.

Penalties

16.(1)A person who violates any provision of this order commits an offence punishable on summary conviction as set out in Section 25(1) of the Natural Products Marketing Act R.S.P.E.I. 1988, Cap. N-3 and also may have his license suspended or revoked.

- (2) Where a violation of any provision continues for more than one day, the offender commits a separate offence for each day that the violation continues.

Export Licensing Order

Application

 This order applies to the control and regulation of potato exporters in Prince Edward Island.

Definition

- 2. In this order
 - 1. "Act" means the Natural Products Marketing Act R.S.P.E.I. 1988, Cap. N-3;
 - 2. "Board" means the Prince Edward Island Potato Board established pursuant to the Act:
 - 3. "Dispute Resolution Corporation" means the Fruit and Vegetable Dispute Resolution Corporation established in 1999 pursuant to Article 707 of the North American Free Trade Agreement;
 - 4. "Exporter" means a person who, on his own behalf or as an agent for or on behalf of any other person, is engaged in the marketing of potatoes outside of Canada and the United States (including Puerto Rico);
 - 5. "Exports" or "exported" means marketing potatoes outside of Canada and the United States (including Puerto Rico);
 - 6."Marketing" means buying, selling or offering for sale, and includes storing, packing, shipping, and transporting in any manner by any person;
 - 7. "Person" includes individual, cooperative, partnership, or corporation;
 - 8. "Plan" means any plan established for the marketing of potatoes established and amended from time to time pursuant to the Act;
 - 9."Potatoes" means potatoes produced in Prince Edward Island;
 - 10. "Producer" means a person who, in Prince Edward Island, grows potatoes on his own land or on land owned by others; and
 - 11. "Responsibly connected person" includes individual owners, partners, members, officers, directors or holders of more than 10% of the outstanding stock of a business, and any individuals who function in an executive or managerial capacity.

Application of provisions

This order does not apply to potatoes marketed in Canada and the United States, including Puerto Rico. Licensing

- 4.(1) No person shall engage in the export of potatoes without a license from the Board.
 - 2. All potatoes exported from Prince Edward Island shall be exported only through licensed potato exporters.

Fees

- 5. (1) The license fee payable to the Board by all exporters engaged in exporting potatoes shall be \$5,000 plus applicable taxes annually and such license shall be issued to an exporter only on the exporter agreeing to the terms and conditions as set forth in the application for the license.
- (2) Applicants applying for an exporter's license shall consent to a credit inquiry to be carried out by the Board. The Board shall have the right to deny the issuance of an exporter's license to any applicant for whom an unsatisfactory credit report is received.
- (3) Applicants applying for an exporter's license shall provide to the Board written confirmation from the applicant's financial institution indicating that the applicant has established a line of credit for a minimum of \$250,000.

Collection and remittance of levies

6. Each exporter engaged in the export of potatoes in Prince Edward Island shall pay a charge to the Board of three cents per hundredweight for potatoes shipped by the exporter. In addition, each exporter shall collect and remit to the Board the prescribed producer levies for such shipments as set out in Board Order 06-1 (Levies Order) as amended or substituted from time to time.

Application deadline

 Applications for exporter licenses must be received by the Board by no later than July 31st of each year.

Licence issuance

- 8.(1) Licenses shall be issued by the Board annually on August 1st of each year.
 - (2) No person shall be issued a license unless that person is a member in good standing in the Dispute Resolution Corporation, and the license of that person shall be suspended immediately by the Board if the person's membership in the Dispute Resolution Corporation is suspended, cancelled, or terminated for any reason.

Violation

9.

If a licensed exporter, or any other entity in which a responsibly connected person of the licensed exporter has an interest, is found to have violated any provision of a plan or any order or regulation of the Board, the licensed exporter shall be liable to have his license suspended or canceled forthwith.

Expiry

10. All licenses shall expire on the 31st day of July in each year.

Renewal

11. Any exporter who is in arrears with the Board with respect to any levies shall, in addition to any other penalty therefor, not be entitled to a renewal of any license required by any licensing regulations in force from time to time until such time as all arrears of levies are paid to the Board.

Implied term 12.

The following provision shall be deemed to be included in any written or oral contract between a PEI potato producer and licensed PEI Potato Exporter for the purchase of potatoes: "Any dispute, controversy or claim arising out of this contract may, at the grower's request, be submitted to, and finally settled by, arbitration administered by the Fruit and Vegetable Dispute Resolution Corporation in accordance with its published rules and procedures. Judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof."

Details of sale 13 to be furnished to Board

All exporters shall, no later than seven days after the shipment has left Prince Edward Island, be required to furnish the Board with the name of the importing country, the size and quantity of the shipment, the average price paid to producers, the shipment date, transportation mode and exit port. The Board will then assign a Board Transportation Order Export Number for the shipment.

Unsatisfied judgments

14.

In the event an unsatisfied judgment is registered against an applicant for an exporter's license, or against any other entity owned or controlled by such applicant which previously held an exporter's license issued by the Board, the Board shall be entitled to refuse to issue an exporter's license to such applicant until all such judgments are paid and satisfied. In addition, it shall be a term and condition of each exporter's license issued by the Board that, in the event that any judgment be registered against such exporter in Prince Edward Island and remain unsatisfied for a period greater than seven days, the license of such exporter shall be liable to suspension or cancellation at the discretion of the Board.

Power to withhold 15.

The Board hereby delegates to such of its employees who, in the ordinary course of their duties as employees of the Board issue Board transportation order export numbers, the power to withhold issuance of further Board transportation order export numbers to an exporter who is in arrears of remittance of levies to the Board, against whom an unsatisfied judgment in Prince Edward Island exists, or who is otherwise in violation of any Plan, order or regulation of the Board.

Penalties 16.(1)

A person who violates any provision of this order commits an offence punishable on summary conviction as set out in Section 25(1) of the Natural Products Marketing Act R.S.P.E.I. 1988, Cap. N-3 and also may have his license suspended or revoked.

- (2) Where a violation of any provision continues for more than one day, the offender commits a separate offence for each day that the violation continues.

PRINCE EDWARD ISLAND POTATO BOARD

UNDER the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, the Prince Edward Island Potato Marketing Plan Regulations, and the *Agricultural Products Marketing Act* (Canada), the Prince Edward Island Potato Board makes the following order:

Levies Order

- Application 1. This order provides for the fixing, imposing and collecting of levies from potato dealers, exporters, processors and producers in Prince Edward Island.
- Definition 2. In this order
 - 1. "Act" means the Natural Products Marketing Act R.S.P.E.I. 1988, Cap. N-3;
 - 2. "Board" means the Prince Edward Island Potato Board established pursuant to the Act;
 - 3. "Dealer" means a person who, on his own behalf or as an agent for or on behalf of any other person, is engaged in the marketing of potatoes in Canada and the United States, including Puerto Rico;
 - 4. "Exporter" means a person who, on his own behalf or as an agent for or on behalf of any other person, is engaged in the marketing of potatoes outside of Canada and the United States (including Puerto Rico);
 - 5. "Person" includes individual, cooperative, partnership, or corporation;
 - 6."Plan" means any plan for the marketing of potatoes established and amended from time to time pursuant to the Act;
 - 7."Potatoes" means potatoes produced in Prince Edward Island;
 - 8. "Processor" means a person who, on his own behalf or as an agent for or on behalf of any other person, is engaged in the processing of potatoes; and
 - 9. "Producer" means a person engaged in the production of potatoes for his own account.
- Levy structure 3.(1) Every person engaged in the processing of potatoes in Prince Edward Island shall pay to the Potato Board, in addition to the license fees set out under the Plan, levies at the rate of nine (\$0.09) cents per cwt on all potatoes used by him for processing purposes in the Province of Prince Edward Island. If such person, having purchased potatoes produced in Prince Edward Island, processes such potatoes outside of Prince Edward Island in a plant or plants owned or controlled by such person, he shall pay to the Potato Board, in addition to the license fees set out under the plan, levies at the rate of nine (\$0.09) cents per cwt on all Prince Edward Island potatoes used by him for processing purposes outside the Province of Prince Edward Island, provided such person has entered into an agreement with the Potato Board which enables the Potato Board to verify the processing of such potatoes, which agreement shall be in the form approved by the Potato Board.

- 2. Every dealer, exporter and producer shall pay to the Board, in addition to the license fees set out under the Plan, levies in the amount of ten (\$0.10) cents per hundredweight on all potatoes sold or shipped by him except where such potatoes are sold to a processor to whom subsection (1) applies, and until such levies are paid to the Board, every dealer, exporter and producer shall hold the sums representing his liability pursuant to such levies in trust for the Board.
- 3. With respect to potatoes grown prior to 2009, the levies payable pursuant to subsections 3.(1) and 3.(2) shall be seven (\$0.07) cents per cwt and eight (\$0.08) cents per cwt, respectively.

Collection and remittance of levy

- 4.(1) Each person engaged in the processing of potatoes in Prince Edward Island shall, on or before the fifteenth day of each month
 - (a) render to the Board a true and correct statement relating to all potatoes purchased by him during the previous month giving the name and address of the grower and the quantity purchased, together with such further information as the Board may from time to time require; and
 - (b) remit to the Board the levies imposed on him pursuant to subsection 3(1).
- (2) Every dealer, exporter and producer shall, on or before the fifteenth day of each month
 - (a) render to the Board a true and correct statement relating to all potatoes shipped by him during the previous month giving the following information:
 - i. quantities, varieties and pack of the potatoes; and
 - ii. such further information as the Board may from time to time require; and
 - (b) remit to the Board the levies imposed on him pursuant to subsection 3(2).
- (3) The Board shall issue invoices for levies imposed pursuant to subsection 3(2) no later than July 31st of each year to each producer who has sold seed potatoes to producers in Prince Edward Island, based on the volume of such seed from the previous crop year moved by such producer as determined by information provided to the Board by the Canadian Food Inspection Agency with the consent of such producer.
- (4) If by February 28th of each year, a producer fails to consent, or withdraws any previous consent, to the release of information to the Board by the Canadian Food Inspection Agency with respect to the movement of seed potatoes in Prince Edward Island, the Board shall collect the levy on the sale of such seed potatoes sold by such producer in Prince Edward Island on the basis of \$ 16 per acre for each acre of seed potatoes receiving seed certification status by the Canadian Food Inspection Agency in the previous calendar year, and shall invoice such producer on that basis by no later than April 15th of each year.
- 5. This order shall apply to dealers, exporters, processors and producers.
- 6. Board Order PB06-1 is hereby revoked.

7. This order comes into force on the 22^{nd} day of July, 2009.
