UNDER the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap.N-3, the Prince Edward Island Potato Marketing Plan Regulations, and the *Agricultural Products Marketing Act* (Canada), the Prince Edward Island Potato Board makes the following order:

**POTATO PROCESSING CONTRACT ORDER**

Application 1. This order applies to dealings between potato producers and potato processors with respect to supply by producers of potatoes for processing by processors.

Definition 2. In this order

- (1) "Act" means the *Natural Products Marketing Act* R.S.P.E.I. 1988, Cap. N-3;
- (2) "Board" means the Prince Edward Island Potato Board established pursuant to the Act;
- (3) "Person" includes individual, cooperative, partnership, or corporation;
- (4) "Plan" means any plan for the marketing of potatoes established and amended from time to time pursuant to the Act;
- (5) "Potatoes" means potatoes produced in Prince Edward Island;
- (6) "Processing" means
  - (a) canning, dehydrating, chipping, drying, freezing, peeling or processing with any chemical or by heat and combining or mixing potatoes with one or more other vegetables, or
  - (b) entering into a contract for the purchase of potatoes for the purpose of performing on the potatoes any of the operations mentioned in clause (a);
- (7) "Processor" means a person who, on his own behalf or as an agent for or on behalf of any other person, is engaged in the processing of potatoes; and
- (8) "Producer" means a person engaged in the production of potatoes for his own account.

- Form of Contract 3. No producer in the province shall enter into a contract with a processor unless the form of contract for such processor has been approved annually by a meeting of producers consisting of those producers who held contracts with such processor in the previous crop year, which meeting shall be conducted by the Potato Processing Committee constituted by the Prince Edward Island Potato Board. All such contracts shall bear the following notation at the end of the contract:

Form of contract approved by the Prince Edward Island Potato Board

- Prohibition 4. No person shall sell potatoes for processing, and no person shall purchase potatoes for processing, unless such sale or purchase is made pursuant to, and on the terms and conditions contained in, the form of contract for such processor approved in the manner set forth in Section 3.

- Selling 5. Notwithstanding Sections 3 and 4, a processor and producer may at any time subsequent to August 15<sup>th</sup> in any crop year, agree to purchase and sell potatoes produced in that crop year for processing on such terms and conditions as may be agreed upon, and shall not be obliged to enter into the contracts described in Sections 3 and 4.

- Grade Slips 6. Each processor shall, within a period of thirty (30) days following the end of the month in which the potatoes were received and graded by the processor, provide to the Board copies of all grade slips for potatoes received by the processor for processing in the province.

Contract Volumes

- 7.(1) Each processor shall annually provide to the Board, on or before June 30 of each year, a written summary of the volume of potato purchases contracted by the processor for production in that calendar year, stating the volume of each variety contracted.

- 7.(2) If a processor enters into a contract to purchase potatoes for processing purposes subsequent to June 30 of each year, the processor shall provide to the Board, within 15 business days of the contract being signed, a written statement of the volume of potatoes contracted by the processor and the volume of each variety contracted.

- 7.(3) Notwithstanding sub-section 7.(1), for the year 2009 each processor shall provide the written summary of the volume of potato purchases contracted by the processor, stating the volume of each variety contracted, by August 15, 2009.

8. Board Orders PB91-4, PB93-1 and PB00-2 are hereby revoked.

- Commencement 9. THIS ORDER comes into force on the 22<sup>nd</sup> day of July, 2009.
