DFPEI 2009-06 DAIRY FARMERS OF PRINCE EDWARD ISLAND

ORDER:DFPEI 2009-06 EFFECTIVE:1 December 2009

Under the Dairy Farmers of Prince Edward Island Regulations and under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, Dairy Farmers of Prince Edward Island makes the following Order:

LEVIES ORDER

Application

1. This Order provides for the establishment, control and regulation of levies on butterfat delivered by milk producers effective 1 December 2009.

Definitions

2. The words herein shall have the meanings as found in the *Natural Products Marketing Act* and the Dairy Farmers of Prince Edward Island regulations.

Milk producer levies

- 3. (a) Each producer who delivers milk in Prince Edward Island shall pay to the Board a levy of \$0.1867 per kilogram of butterfat on all milk delivered by him for general administration of the Board.
 - (b) Each producer who delivers milk in Prince Edward Island shall pay to the Board a levy of \$0.01 per kilogram of butterfat on all milk delivered by him for dairy industry research.
 - (c) Each producer who delivers milk in Prince Edward Island shall pay to the Board a levy of \$0.3333 per kilogram of butterfat on all milk delivered by him for product promotion.

Revocation

4. Dairy Farmers of Prince Edward Island Order # 2008-03, dated the $28^{\rm th}$ day of November 2008, is hereby revoked.

Commencement

5. This Order comes into force 1 December 2009.

Under the Dairy Farmers of Prince Edward Island Regulations and under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, Dairy Farmers of Prince Edward Island makes the following Order:

MARKETING ORDER

Application

1. This Order applies to the control and regulation of the production and marketing of milk in the province of Prince Edward Island.

Definitions

- 2. The words herein shall have the meanings as found in the *Natural Products Marketing Act* and the Dairy Farmers of Prince Edward Island Regulations and in this Order:
 - (a) "dairy year" shall mean a twelve month period from August 1st in one year to July 31st in the next succeeding year.
 - (b) "Department" shall mean the Prince Edward Island Department of Agriculture.
 - (c) "quota" means a producer's share of the market for milk products as determined by the Board and assigned to a producer by the Board.

Daily quota

3. Quota assigned by the Board to a registered quota holder shall be expressed in kilograms of butterfat per day rounded to one decimal place.

Minimum Quota Holding

4. A producer must hold a minimum of 10 Kg of daily quota to market milk. Producers who hold less then 10 Kg of daily quota as of 31 December 2009 may continue to market milk based on their quota holdings as of that date or if they increase their quota holdings after that date, but may not market milk if they sell or transfer any portion of their quota. Exceptions may be considered by the Board only if a producer intends to market all milk from his farm through on farm processing.

Monthly quota

5. The amount of quota available to a registered quota holder that markets milk in a calendar month shall be the sum of the daily quota held by the registered quota holder on each day of the month rounded to the nearest kilogram of butterfat.

Quota credit system

6. Recognizing that milk producers efforts to fill their daily quota shall result in production either slightly above or slightly below their monthly quota, the Board shall allow milk producers to over ship up to a maximum of ten (10) times their daily quota on a cumulative basis, referred to as Over Quota Production Credits, or to under ship up to a maximum of twenty (20) times their daily quota on a cumulative basis, referred to as Under Quota Production Credits.

Maximum over quota

production credits

(1) The maximum number of over quota production credits available to a milk producer shall be determined by the Board by multiplying a milk producer's daily quota holdings at the end of a month by ten.

Maximum under quota production credits

(2) The maximum number of under quota production credits available to a milk producer shall be determined by the Board by multiplying a milk producer's daily quota holdings at the end of a month by twenty.

Idem

(3) A milk producer shipping slightly under quota in a month shall be allowed to offset all or part of the under production against Over Quota Production Credits carried forward from the previous month, or to carry forward the Under Quota Production Credits to future months to offset future over quota production provided that the cumulative under production of the producer does not exceed twenty (20) times the producer's daily quota.

Idem

(4) A milk producer shipping slightly over quota shall be allowed to offset all or part of the over quota production against Under Quota Production Credits carried forward from the previous month or to use available Over Quota Production Credits provided that the cumulative over quota of the producer does not exceed ten (10) times the producer's daily quota.

Responsibility for accumulated over quota production credits

(5) A milk producer shall be financially responsible to the Board for the value of all accumulated over quota production credits at the time the producer exits the industry.

Value of over quota production credits

(6) The value of over quota production credits accumulated by a producer shall be calculated by the Board and shall equal the value of blended component returns from the All Milk Pool received by the Board for the month in which the producer is financially responsible to the Board.

Payment method

- (7) A producer may compensate the Board for the value of accumulated over quota production credits in any of the following manners:
 - (a) In the case where a producer exiting the industry by transferring his quota to a purchaser of his on-going dairy enterprise, or to a new producer relocating the quota to a non-producing farm location, the accumulated over quota production credits may be transferred to the purchaser of the quota provided the purchaser agrees to the transfer, in writing, to the Board.
 - (b) In the case where a producer is exiting the industry by selling his quota on the Quota Exchange, the producer may pay the Board for the value of accumulated over quota production credits from the proceeds of quota sold.

Non-payment of accumulated over quota production credits

(8) Where a producer has not paid the Board for the value of accumulated over quota production credits, the Board shall deduct the value of the accumulated over quota production credits from payments due to the producer, including payments for quota sold by the producer on the Quota Exchange.

Idem

(9) The Board shall not approve a transfer of quota from one producer to another producer where the Board has not been compensated for the value of accumulated over quota production credits held by the transferor.

Transfer of under quota production credits

(10) A producer may only transfer under quota production credits to a purchaser of his on-going dairy enterprise or to an immediate family member where the Board has approved the transfer of all the quota holdings of the producer to an immediate family member.

Seasonal quota incentives

7. The Board may, from time to time, offer registered quota holders seasonal quota incentives to promote the delivery of additional milk required to meet seasonal demand for dairy products during certain periods of the year. Such incentives shall be temporary in nature, shall be expressed in kilograms of butterfat and shall not form part of a registered quota holder's quota holdings.

Payment of levies

8. No registered quota holder shall market milk without paying the fees, service charges or levies fixed by the Board.

Ownership of cows and land

9. No registered quota holder shall market milk that is not produced by cows owned, leased or rented by him and located on property owned, leased or rented by him.

Shipments in registered name

10. No registered quota holder shall ship or sell milk under the name of any other person or under any other designation. A registered quota holder must ship and sell in the name under which he has been registered, all the milk sent to market from his farm.

Processors receiving milk

11. No processor shall receive milk from a registered quota holder who is not in possession of a registration number and a quota assigned by the Board.

Quotas property of Board

12. Quotas are the property of the Board and are not transferrable between registered quota holders except as provided for in Board Orders.

Non-production

13. A registered quota holder who ceases to market milk in three consecutive calendar months shall have his quota revert to the Board.

Catastrophes

14. A registered quota holder who has reduced deliveries or discontinued production temporarily due to a catastrophe, may apply to the Board for relief from Board Orders.

Idem

(1) a catastrophe may include severe injury, severe illness or death of the registered quota holder or the person(s) responsible for the dairy herd, the sudden death or loss of a significant part of the milking herd or destruction of the production facilities.

Relief available

(2) The Board may grant a producer that has suffered a catastrophe one or both of the following:

(a) An exemption from the registered quota holder's quota reverting to the Board for a period of up to twenty-four (24)consecutive months after the catastrophe occurred, or

(b) Approval for the producer to lease all or part of the producer's daily quota to another registered quota holder(s) for a period of up to twenty-four consecutive months after the catastrophe occurred.

Catastrophe clause lease policy

(3) The Board shall establish and maintain a Catastrophe Clause Quota Leasing Policy that may be amended from time to time and the Board shall make the policy, or any amendments made thereto, available to all registered quota holders.

Lost under quota production credits

(4) The Board shall not reinstate under quota production credits lost by any producer for any reason.

Quota adjustments

15. The Board may, from time to time, adjust producer quota holdings to reflect changes in demand for dairy products. Such adjustments shall be made to the quota holdings of all registered quota holders on a pro-rata basis.

Ouota reserve

16. The Board may, at its discretion, hold an amount of quota in reserve.

Transfers of quota

- 17. Quotas may be transferred under the following conditions:
 - (1) In the case of off-farm transfers, from a father to a son or daughter or from a mother to a son or daughter provided no conditions or restrictions are in effect on the quota holdings of the transferor or transferee pursuant to other sections of this Order or any other Order of the Board.
 - (2) To the purchaser of an on-going dairy enterprise where the purchaser is a new producer and has purchased all land, buildings, dairy equipment and all the milking herd. Such transfers shall be conditional on the producer marketing all milk from the purchased farm location for at least twenty-four consecutive months after the date of purchase or such quota shall revert to the Board.
 - (3) To the purchaser of an on-going dairy enterprise where the purchaser is a registered producer and has purchased all land, buildings, dairy equipment and all the milking herd, with the intent of expanding his dairy enterprise. Such transfers shall be conditional on the producer marketing all milk from the new farm location for at least twenty-four consecutive calendar months after the date of purchase or such quota transferred shall revert to the Board.
 - (4) To a new producer where the quota is being transferred from a retiring producer and the new producer wishes to relocate the quota to a non-producing farm location, provided that the new producer shall not be allowed to combine the quota with any other quota for at least five (5) years.
 - (5) To a producer who has purchased quota through the Quota Exchanges operated by the Board under the Quota Exchange Order.

Lease equivalent to purchase

18. For the purposes of determining eligibility for a transfer of quota under sections 17(2) and 17(3) the Board may consider as equivalent to a purchase, a long term lease (five years or more) which contains an offer to purchase clause.

Prior Board approval required	19. All transfers of quota are subject to prior approval by the Board.
Quota reserve	20. Quota that has reverted to the Board due to a producer failing to comply with Board Orders shall become part of a reserve, which may be distributed by the Board to qualifying producers on a basis determined by the Board.
Processor	
deductions	21. Each processor shall deduct from monies payable to a producer any levies established by a Board Order and shall remit the said levies to the Board by the twentieth of the month following the month the milk was delivered.
Processor reports	22. Each processor shall supply the Board with a report of each producer's deliveries and the amount of levies collected in a form acceptable to the Board.
Establishment of provincial quota	23. The Board, from time to time, shall determine the amount of quota needed to produce sufficient milk to meet the province's quota share.
Quota allocation	24. The Board shall allocate the provincial quota to all registered quota holders based on a percentage of their quota holdings compared to the total provincial quota holdings.
Quota adjustments	25. The Board may adjust producer quotas at any time to reflect an increase or decrease in the quota allocated to the province, market conditions or production variances.
Pro Rata	26. Where a quota adjustment is necessary, such adjustments shall be assessed, pro rata to all registered quota holders.
Cancellation of quota	27. The Board may cancel all or part of a producer's quota where the producer has contravened any Order of the Board.
Revocation	$28. Prince\ Edward\ Island\ Milk\ Marketing\ Board\ Order\ MMB\ 01-02, is\ hereby\ revoked.$

Under the Dairy Farmers of Prince Edward Island Regulations and under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, Dairy Farmers of Prince Edward Island makes the following Ordon:

MILK PRODUCER QUOTA EXCHANGE ORDER

Application

1. This Order provides for the establishment, control and operation by the Board of a Quota Exchange to be operated for milk producers.

Definitions

- 2. The words herein shall have the meanings as found in the Prince Edward Island *Natural Products Marketing Act* and the Dairy Farmers of Prince Edward Island Regulations unless differentiated herein, and as hereinafter defined:
 - (a) "cleared" shall mean the process by which the Board shall conduct the buying and selling of quotas which results in the purchase and sale of quotas.
 - (b) "daily quota" shall mean the amount of kilograms of butterfat quota assigned to a producer by the Board, expressed to one decimal point.
 - (c) "exchange month" shall mean the calendar month in which a producer's quota shall be adjusted by the amount of quota purchased or sold on the exchange.
 - (d) "market clearing price" shall be the price at which the amount of quota offered for sale on an exchange equals, or comes closest to, the amount of quota bid for, except that where the volume is the same for more than one price, the lowest price shall be used.

Exchange established

3. The Board hereby establishes a quota exchange, to be operated by the Board, for the purchase and sale of daily quota held by milk producers.

Eligible producers

4. Only producers registered by the Board shall be eligible to participate on the quota exchange.

Offer prices

5. The price at which milk producers may offer to sell or purchase quota on the exchange is limited to a maximum of twenty nine thousand dollars (\$29,000.00) per Kg of daily quota for the exchange operating in December 2009 that results in quota transfers effective 1 January 2010. The maximum price that milk producers may offer to sell or purchase quota on the exchange will decrease by one hundred twenty-five (\$125.00) per month each month (as detailed in Appendix A to this order) until the maximum price reaches twenty five thousand dollars (\$25,000.00) for the exchange operating in the month of August 2012. The maximum price that milk producers may offer to sell or purchase quota on the exchange will then continue at twenty-five thousand dollars (\$25,000.00) unless amended by the Board.

Bids to be Excluded

6. Any bid to purchase or sell quota that exceeds the monthly maximum specified in this order (as detailed in Appendix A) shall be excluded from the exchange and returned to the bidder.

Offer amounts

7. Producers may offer to sell or purchase any amount of daily quota in increments of 0.1 kilograms, except that a producer may not offer to sell more than the amount of the seller's quota holdings.

Offer forms

8. Producers offering to sell or purchase quota on the exchange shall only submit offers on a form provided by, or approved by, the Board.

Delivery of forms

9. Offers to sell or purchase quota must be received at the Board Office by the close of business on the 15th of the month prior to the exchange month. The Board will accept a facsimile copy of an offer to sell or purchase quota on or prior to the close of business on the 15th of the month, provided that the producer mails an original signed copy of the form to the Board within one day of the facsimile copy being sent.

Weekends and holidays

10. Where the 15th of a month falls on a weekend or a statutory holiday, the Board shall accept offers to sell or purchase quota up to the close of business on the next business day.

Change or cancellation of offers

11. A producer may change or cancel an offer to sell or purchase quota provided that such change or cancellation is made in writing and the notice of change or cancellation is received at the board office prior to the close of business on the 15^{th} of the month prior to the exchange month.

Determination of market clearing price

- 12. Offers to sell and bids to purchase quota shall be used to establish the market clearing price of the exchange in the following manner:
 - (1) Offers to sell quota shall be accumulated based on the prices at which the quota is offered for sale, from the lowest to the highest price offered.
 - (2) Offers to purchase shall be accumulated based on the prices at which producers have bid for quota, from the highest price to the lowest bid price.
 - (3) If no point is reached where the amount of quota offered for sale is equal to, or nearly equals, the amount of quota bid for on an exchange, the exchange shall be deemed to have not cleared and no transactions shall take place on that exchange.

Selection process

- 13. Where the amount of quota offered for sale and bid for at the clearing price does not equal, the Board shall distribute the available quota in the following manner:
 - (1) If the amount of quota offered for sale at or below the clearing price is greater than the amount of quota bid for at the clearing price, the Board shall sell the quota offered for sale based on the order in which the offers to sell were received at the board office.

(2) If the amount of quota bid for at or above the clearing price is greater than the amount of quota offered for sale at the clearing price, the amount of quota sold shall be distributed in 0.1 kilogram lots until the amount of quota offered for sale at or below the clearing price is fully distributed.

Clearing date

14. The Board shall establish the clearing price, clear the exchange and release the exchange results by noon of the second business day following the last day the bids for the exchange are accepted.

Settlements

- 15. Producers offering to purchase quota on an exchange shall provide the Board with one of the following:
 - (1) A cheque, payable to the Board, which covers the full amount of the offer to purchase, plus the appropriate service charge, dated no later than the 25th of the month prior to the exchange month, or
 - (2) A letter from a reputable financial institution or legal firm that indicates the amount of the offer to purchase will be paid to the Board on the date required.

Purchases in excess of \$25,000

16. Where the offer to purchase exceeds \$25,000, the producer shall provide the Board with a letter from a responsible financial institution which indicates that the producer has made the necessary financial arrangements to have the cheque honoured on presentation by the Board.

Deposit of cheques

17. The Board shall deposit cheques for successful purchases on the 25th of the month prior to the exchange month except that where the 25th falls on a weekend or a statutory holiday the Board shall deposit the cheques on the next business day.

Settlements to purchasers

18. The Board shall issue settlements to purchasers of quota for overpayments on the tenth (10th) day of the exchange month.

Settlements to

sellers

19. The Board shall issue settlements to sellers of quota on the tenth (10^{th}) day of the exchange month.

Adjustments to producer quotas

20. The Board shall debit sellers quota with the amount of quota sold and credit purchasers quota with the amount of quota purchased on the 1st day of the exchange month.

Service charges

21. Producers shall pay to the Board a service charge of \$3.00 for each successful offer to sell or purchase quota and for each change in an offer as provided for in Section 11.

Failure to pay for quota

22. Where a producer fails to pay the Board for the amount of quota purchased, or where a cheque provided to the Board by a producer in payment of quota purchased has been dishonoured by a financial institution, the Board shall offer a sufficient amount of the producer's quota on the next exchange to clear the total amount owing to the Board, at the clearing price of that exchange, provided the producer has not paid the Board by the exchange clearing date.

Under the Prince Edward Island *Natural Products Marketing Act* R.S.P.E.I. 1988, Cap.N-3; the Prince Edward Island Hog Commodity Marketing Plan, and the *Agricultural Products Marketing Act* (Canada) and the regulations made thereunder, the Prince Edward Island Hog Commodity Marketing Board makes the following Order:

LEVY ORDER

Application

1. This Order applies to the establishment of a levy payable by a producer to the Board for services rendered or to be rendered by the Board.

Definitions

- 2. The meaning of the words herein shall be as defined in the Prince Edward Island Hog Commodity Marketing Plan or the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3 and as hereinafter defined:
 - (a) "calendar week" means the days Sunday through Saturday inclusive;
 - (b) "month" means a calendar month as per the federal livestock calendar;
 - (c) "processor" means a person who slaughters hogs or has hogs slaughtered on his/her behalf.

Levy

- 3. (1) The Board establishes a levy of \$1.73 per market hog, sow, boar or stag marketed. This levy includes \$1.10 for general administration of the Board, including product promotion, \$0.13 for CPC membership dues and \$0.50 for PEIQS Debt Servicing.
 - (2) The levy shall be deducted by the processor, and the processor shall remit the levy to the Board within seven days of the deduction.

Remittance

- 4. (1) Every processor, within seven days of each calendar week, shall:
 - (a) render to the Board a true and correct statement of all market hogs, sows, boars and stags slaughtered in the previous calendar week; and
 - (b) remit to the Board the levy outlined in Section 3 above.
 - (2) Notwithstanding subsection (1), a processor, with the approval of the board, within seven days of each month, shall;
 - (a) render to the Board a true and correct statement of all market hogs, sows, boars, and stags slaughtered in the previous month; and
 - (b) remit to the Board the levy outlined in Section 3.

Revocation

5. Board Order 04-02 is hereby revoked.

Commencement

6. This Order comes into force on December 1, 2009.

BOARD ORDER: HCMB09-02 EFFECTIVE 01 December 2009

Pursuant to and under the authority of the Prince Edward Island Natural Products Marketing Act R.S.P.E.I. 1988, Cap. N-3 and the Prince Edward Island Hog Commodity Marketing Plan and the Agricultural Products Marketing Act R.S.C. 1985, Chap. A-6 and regulations made thereunder, the Prince Edward Island Hog Commodity Marketing Board makes the following order:

LICENSING ORDER

Application

1. This order applies to the licensing of producers, buyers, dealers, assemblers, transporters and processors of hogs produced and marketed in the Province of Prince Edward Island and for hogs produced in Prince Edward Island that are marketed in interprovincial and export trade.

Interpretation

2.The meaning of words herein shall be as defined herein or if not defined herein then as in the Prince Edward Island Hog Commodity Marketing Plan, or the Natural Products Marketing Act R.S.P.E.I. 1988, Cap. N-3.

Definitions

- 3. In this order
 - (a) "assemble" is to bring hogs together in one facility, that is designed and maintained for that purpose;
 - (b) "buyer or dealer" is a person who purchases hogs from a producer for resale;
 - (c) "Plan" means the Natural Products Marketing Act Hog Commodity Marketing Regulations;
 - (d) "processor" means a person who slaughters hogs;
 - (e) "producer" means a resident of Prince Edward Island who is engaged in the production, or feeding of hogs;
 - (f) "R.O.P. hogs" means record of performance hogs which are sold for breeding purposes;
 - (g) "transporter" means a person who assembles and/or hauls hogs in any manner, but does not include:
 - (i) a producer who hauls in a vehicle owned or rented by him, and driven by him or an on-farm employee, only the hogs produced by him;
 - (ii) a person who is employed by and driving a vehicle owned by the holder of a license as a transporter of hogs;
 - (iii) processor who bought the hogs under the Plan and the regulations;
 - (h) "hog" means any member of the species Sus scrofa (domestic pig);

(i) "person" shall include any partnership, corporation, cooperative, syndicate, or other business group formed or existing for the purpose of jointly acquiring or administering assets.

Producer

licenses

4. (1) Except as provided for in section 5, no person shall market fifty hogs, or more, or own ten brood sows or stud boards or more in a calendar year without a producer license from the board.

Application for license

(2) An application for a license as a producer of hogs shall be submitted on a form provided by the Board and any licenses issued to a person as a producer of hogs shall be contained in a form provided by the Board.

Forecasted marketings

(3) Periodically at the request of the Board, a producer shall provide the Board with a forecast of marketings.

Where application not required

- (4) Provided he complies with the orders of the Board, the Plan and the Act, any person presently engaged in the production of hogs for market
 - (a) who marketed fifty hogs or more during the past twelve-month period;
 - (b) who has owned a minimum of ten (10) brood sows or stud boars during the past twelve-month period;

may, without application therefore, be issued a license by the Board.

Suspension or revocation

- (5) All licenses may be suspended or revoked by the board for any of the following reasons:
 - (a) the producer fails to observe, perform or carry out the provisions of board orders, the Plan, or the Acts;
 - (b) the producer ceases to be a producer for a continuous period of one year, or a producer under the requirements of clause (c) of this section; provided, however, that the board may thereupon grant a new license to the producer for the operation;
 - (c) the producer does not market fifty hogs, or more, or does not own ten brood sows or stud boars or more in a twelve month period.
 - (d) the producer does not provide the Board with a forecast of marketings as required under subsection 4(3).

Fee (6) There is no fee for a producer license.

Refusal (7) The board may refuse to issue new licenses to new entrants into the hog

industry if an overall provincial production quota set by the board is being

exceeded.

Transfer (8) Licenses may, subject to the approval of the board, be transferable to another person provided that person complies with the provisions of section 3.

Export License

5. (1) No person shall market hogs produced in Prince Edward Island in interprovincial and export trade without first obtaining an Export Licence from the Board.

Term of license

(2) An export license issued by the Board shall expire twelve months from the date of issue.

Export license applications

(3) Upon application to the Board, on a form provided by the Board, the board may issue an export license on such terms and conditions as the board determines are necessary to effectively promote, control and regulate the hog industry in Prince Edward Island.

Fee

(4) The fee for an export license shall be \$100.00.

Export shipment permits

(5) The Board shall use an export shipment permit and/or manifest system to regulate and control the marketing of hogs produced in Prince Edward Island that are marketed in interprovincial and export trade.

Idem

(6) No person shall market a shipment of hogs produced in Prince Edward Island in interprovincial and export trade unless the person has been granted an Export License and has either applied for an export shipment permit on a form provided by the Board, and has received an export permit provided by the Board, or has used a sequentially numbered manifest, issued by the Board.

Register of Producers

6. Every licensed hog producer who complies with the orders of the board, the Natural Products Marketing Act and regulations passed thereunder and who has owned a minimum of ten (10) brood sows or stud boars, or has owned and marketed a minimum of fifty hogs during the previous twelve months prior to his being granted a license, may be placed on the register of producers of the board, provided said producer is of the age of eighteen years for the purpose of registration and provided that the producer's signature is on file with the board, or the Returning Officer as provided by the board orders, or the Plan, or the Natural Products Marketing Act and regulations passed thereunder. Any application for a license on file with the board shall be deemed to be an application for registration as a registered producer and the signature on the application form shall be the signature required to compare with the signature on the counterfoil for voting purposes.

Processor licenses

7. (1) No person shall commence, or continue to engage in the processing of hogs except under the authority of a license as a processor of hogs issued by the Board.

Idem

(2) No license as a processor of hogs shall be issued except upon application therefore on a form provided by the Board.

Expiry

(3) A license as a processor of hogs expires on the 31st day of March next following the date on which the license is issued.

License fee

(4) The license fee to a processor shall be the sum of \$10.00 for processors processing less than 500 hogs per year, and \$100.00 for processors processing 500 hogs or more per year.

 - (a) To abide by all Orders of the Board made pursuant to the Hog Commodity Marketing Regulations and the Natural Products Marketing Act.

- (6) A person who is granted a license as a transporter shall agree to the following as a condition of license:
 - (a) To abide by all Orders of the Board made pursuant to the Hog Commodity Marketing Regulations and the Natural Products Marketing Act; and
 - (b) To adopt Agriculture Canada's Recommended Code of Practice for Care and Handling of Pigs. (Publication 1771/E)
- 9. (1) The Board requires all producers, unless exempted herein, to sell hogs produced by them only to processors and buyers licensed by the Board.

- (d) any other relevant information.

- (2) The Board may refuse to grant a license where in the opinion of the Board the applicant is not qualified by experience; financial capability and responsibility; and facilities and equipment to engage properly in the business for which the application was made, or for any reason that the Board deems proper.
- (3) The Board may suspend, or revoke, or refuse to renew a license for failure to observe, perform or carry out the Board's Licensing Order and amendments thereto or the provision of the Natural Products Marketing Act or regulations made thereunder, or any order or direction of the Board or its agent.
