PUBLIC HEALTH ACT NOTIFIABLE AND COMMUNICABLE DISEASES REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated 14 April 2010.)

Pursuant to section 23 of the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30, Council made the following regulations:

- 1. Section 17 of the *Public Health Act* Notifiable and Communicable Diseases Regulation (EC330/85) is amended
 - (a) by addition of the following after paragraph (a)(ii)(C): (C.1) Clostridium Difficile,
 - (b) in paragraph (a)(x)(G), by addition of the words "and non-B" after the words "Haemophilus Influenzae B";
 - (c) in subclause (a)(xvi), by the deletion of the word "and";
 - (d) in subclause (a)(xvii), by the deletion of the semicolon and the addition of the words ", and"; and
 - (e) by the addition of the following after subclause (a)(xvii): (xviii) novel organisms;
- 2. These regulations come into force on April 24, 2010.

EXPLANATORY NOTES

SECTION 1 adds Clostridium Difficile, non-B Haemophilus Influenzae infections, and novel organisms to the list of diseases that must be reported under the regulations.

SECTION 2 provides for the commencement of these regulations.
