**EC2010-283**

**CHILD PROTECTION ACT  
REGULATIONS  
AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated 18 May 2010.)

Pursuant to section 60 of the *Child Protection Act* R.S.P.E.I. 1988, Cap. C-5.1, Council made the following regulations:

**1. Section 1 of the *Child Protection Act* Regulations (EC215/03) is amended**

**(a) in clause (a), by the deletion of the words “*Child Protection Act* Stats. P.E.I. 2000(2nd), c.3” and the substitution of the words “*Child Protection Act* R.S.P.E.I. 1988, Cap. C-5.1”; and**

**(b) by the revocation of clause (e).**

**2. Clause 8(1)(b) of the regulations is amended by the deletion of the words “child welfare” and the substitution of the words “child protection”.**

**3. (1) Subsection 15(1) of the regulations is amended**

**(a) in clause (a), by the deletion of the words “Child Welfare” and the substitution of the words “Child Protection”;**

**(b) in clauses (b) and (e), by the deletion of the words “child welfare” and the substitution of the words “child protection”; and**

**(c) in clause (f), by the deletion of the words “welfare of children” and the substitution of the words “best interests of children”.**

**(2) Subsection 15(4) of the regulations is amended by the deletion of the words “shall in no case be longer than” and the substitution of the words “may not exceed”.**

**4. These regulations come into force on June 1, 2010.**

**EXPLANATORY NOTES**

**SECTION 1** changes the reference to the “*Child Protection Act* Stats. P.E.I. 2000 (2nd), c.3” to the “*Child Protection Act* R.S.P.E.I. 1988, Cap. C-5.1”.

**SECTION 2** amends various provisions of the Act to replace the term “child welfare” with the term “child protection”.

**SECTION 3** changes the name of the “Director of Child Welfare” to the “Director of Child Protection”.

**SECTION 4** provides for the commencement of these regulations.
