ENVIRONMENTAL PROTECTION ACT ENVIRONMENTAL ASSESSMENT FEES REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated 8 March 2011.)

Pursuant to section 25 of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, Council made the following regulations:

- **1. Subsection 3(1) of the** *Environmental Protection Act* **Environmental Assessment Fees Regulations** (EC244/05) **is amended by the addition of the words** ", other than a Crown corporation listed in Schedule B of the *Financial Administration Act* R.S.P.E.I. 1988, Cap. F-9," **after the words** "A person".
- 2. These regulations come into force on March 19, 2011.

EXPLANATORY NOTES

SECTION 1 provides clarification that Crown corporations listed in Schedule B of the *Financial Administration Act* are exempt from the payment of fees when those corporations file proposals under subsection 9(1) of the *Environmental Protection Act*.

SECTION 2 provides for the commencement of these regulations.
