# PUBLIC INQUIRIES ACT PEI ENERGY COMMISSION COMMISSION ESTABLISHED APPOINTMENT OF COMMISSIONERS

On recommendation from the Honourable Premier and President of the Executive Council and pursuant to the *Public Inquiries Act*, R.S.P.E.I. 1988, Cap. P-31, Council established the PEI Energy Commission to inquire into and provide advice on ways in which Prince Edward Island's high cost of electricity can be structurally reduced and/or stabilized over the longer term.

Further, Council appointed the following persons as Commissioners to conduct such inquiry:

Michael O'Brien, CA, Charlottetown, Co-chair David Arsenault, CA, Charlottetown, Co-chair Gerald Morneau, P.Eng., Summerside Richard Hassard, MBA, Goose River Roger King, P.Eng., MBA, Hunter River

And further, Council advised that the inquiry is directed to examine, inquire into and report as follows:

- Under the Prince Edward Island Energy Accord, the Province has assumed short term debt associated with Point Lepreau refurbishment; the Commission will provide recommendations on how Point Lepreau deferral costs can best be financed over the longer term;
- Examine and provide recommendations on long-term ownership and management of electricity on Prince Edward Island including the advantages and disadvantages of public ownership or government owning generation with private control of transmission and distribution;
- 3. This examination will draw on a review of best practices in other jurisdictions;
- 4. In addition to the work being undertaken by the Province to secure federal funding for a new cable, provide mitigation advice as it may relate to a new cable;
- Provide advice and direction with regard to further regional energy collaboration, including demandside management approaches;
- Provide advice and direction on how Prince Edward Island can further advance its environmental stewardship responsibilities related to electricity;
- 7. Examine and comment on all cost elements associated with Prince Edward Island's current system;
- Provide advice and recommendations as to the future role of the Prince Edward Island Energy Corporation, the Island Regulatory and Appeals Commission (as it relates to electricity), and the Office of Energy Efficiency;
- Provide advice on the optimal scope and size that locally generated electricity from renewal energy sources can play in addressing Prince Edward Island's future energy goals;
- Other matters in keeping with the overall goals of the Prince Edward Island Energy Accord, as agreed by the Commission and Government.

And further, Council directed the Commissioners to seek the views of individuals and organizations concerned with the subject matter of the inquiry and empowered them to:

- adopt such procedures and methods as they deem appropriate for the proper conduct of the inquiry;
- exercise all powers conferred upon them by the Public Inquiries Act; and
- seek and expect such assistance of officers and employees of the departments and agencies of the Government of Prince Edward Island in any way they may require for the conduct of the inquiry.

And further, Council directed that the Commissioners present a final report of their findings and recommendations to the Lieutenant Governor in Council by September 2012.

TO ALL TO WHOM these presents shall come or whom the same may in any wise concern:

GREETING A PROCLAMATION

WHEREAS pursuant to provisions of the *Public Inquiries Act*, R.S.P.E.I. 1988, Cap. P-31, the Lieutenant Governor in Council, by Order-in-Council EC2011-269 of 7 June 2011, has authorized the appointment of Our Commissioners therein and hereinafter named to inquire into and provide advice on ways in which Prince Edward Island's high cost of electricity can be structurally reduced and/or stabilized over the longer term.

NOW KNOW YOU that by and with the advice of our Executive Council for Prince Edward Island, We do by these Presents nominate constitute and appoint the following persons to be Commissioners to conduct such inquiry to be known as the PEI Energy Commission: Michael O'Brien, CA, Co-chair; David Arsenault, CA, Co-chair; Gerald Morneau, P.Eng.; Richard Hassard, MBA; and Roger King, P.Eng, MBA;

TO HAVE, HOLD, exercise and enjoy the said office, place and trust unto Our said Commissioners, Michael O=Brien, David Arsenault, Gerald Morneau, Richard Hassard, and Roger King, together with the rights, powers privileges and emoluments unto the said office, place and trust of right and by law appertaining during Our Pleasure;

AND WE DO HEREBY direct Our said Commissioners to examine, inquire into and report as follows:

- 14. Under the Prince Edward Island Energy Accord, the Province has assumed short term debt associated with Point Lepreau refurbishment; the Commission will provide recommendations on how Point Lepreau deferral costs can best be financed over the longer term;
- 15. Examine and provide recommendations on long-term ownership and management of electricity on Prince Edward Island including the advantages and disadvantages of public ownership or government owning generation with private control of transmission and distribution;
- 16. This examination will draw on a review of best practices in other jurisdictions;
- 17. In addition to the work being undertaken by the Province to secure federal funding for a new cable, provide mitigation advice as it may relate to a new cable;
- Provide advice and direction with regard to further regional energy collaboration, including demandside management approaches;
- Provide advice and direction on how Prince Edward Island can further advance its environmental stewardship responsibilities related to electricity;
- 20. Examine and comment on all cost elements associated with Prince Edward Island's current system;
- Provide advice and recommendations as to the future role of the Prince Edward Island Energy Corporation, the Island Regulatory and Appeals Commission (as it relates to electricity), and the Office of Energy Efficiency;
- Provide advice on the optimal scope and size that locally generated electricity from renewal energy sources can play in addressing Prince Edward Island's future energy goals;
- Other matters in keeping with the overall goals of the Prince Edward Island Energy Accord, as agreed by the Commission and Government;

AND WE DO FURTHER authorize Our said Commissioners to adopt such procedures and methods for all purposes of the inquiry as they may from time to time deem expedient for the proper conduct of the inquiry;

AND WE DO FURTHER authorize Our said Commissioners to be assisted by the officers and employees of the departments and agencies of the Government of Prince Edward Island in any way they may require for the conduct of the inquiry;

AND WE DO FURTHER authorize Our said Commissioners to sit at such times and in such places in Prince Edward Island as may be required;

AND WE DO FURTHER authorize Our said Commissioners to exercise all the powers conferred upon them by the Public Inquiries Act;

AND WE DO hereby direct Our said Commissioners to present a final report of their findings and recommendations to the Lieutenant Governor in Council by September 2012;

AND WE DO FURTHER direct Our said Commissioners to file with the Public Archives and Records Office of Prince Edward Island the papers and records of the inquiry as soon as may be after the conclusion of the Inquiry.
