#### DFPEI 2011-05 DAIRY FARMERS OF PRINCE EDWARD ISLAND

BOARD ORDER: 2011-05 EFFECTIVE: 01 August 2011

Under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap N-3, the Dairy Farmers of Prince Edward Island Regulations thereunder, Dairy Farmers of Prince Edward Island makes the following Order:

#### CLASS 1 MILK PRODUCT PRICE DETERMINATION ORDER

Application 1. This Order provides for the establishment of minimum wholesale and minimum home delivery prices for Class 1 milk products in Prince Edward Island.

Classifications 2. The milk classifications that apply in this Order are those established by the Dairy Farmers of Prince Edward Island, by Order of the Classification of Milk Order No. DFPEI 2010-02.

#### Definitions 3. In this Order:

- (a) "distributor" means a person who purchases a Class 1 milk product from a processor or another distributor and offers for sale or sells the Class 1 milk product to an institution, retail outlet or a consumer;
- (b) "home delivery" means the price charged by a processor or a distributor to a consumer for delivery of a Class 1 milk product directly to the home of a consumer;
- (c) "processor" means a person engaged in the processing of Class 1 milk or a Class 1 milk product; and
- (d) "wholesale" means the price charged by a processor or a distributor to an institution or a retail outlet but does not include the price which consumers pay to a retail outlet.

Sales prices 4. No processor or distributor shall offer for sale or sell a Class 1 milk product at a price less than the price established in section 6.

Purchase prices 5. No distributor shall offer to purchase or purchase a Class 1 milk product at a price less than the minimum price established in section 6.

Minimum wholesale and minimum home delivery prices

Under the Natural Products Marketing Act, R.S.P.E.I.1988, Cap. N-3, and the Dairy Farmers of Prince Edward Island Regulations thereunder, Dairy Farmers of Prince Edward Island makes the following Order:

#### PRICE DETERMINATION ORDER

Application 1. This Order provides for the establishment of the prices for each kilogram of butterfat, protein and other solids contained in milk used in the classes described in the Board's Classification of Milk Order and adjustments to producer payments.

- 2. The words herein shall have the meanings as found in the Prince Edward Island Natural Products Marketing Act and the Dairy Farmers of Prince Edward Island Regulations unless differentiated herein and as hereinafter defined:
- (a) "Class 1 Milk" means the amount of litres of milk that is equal to the volume of sales in litres by a processor or distributor of Class 1 products processed by pasteurization, ultra high temperature treatment or sterilization.
- (b) "Class 1 Milk Product" means standard milk, partly skim milk, skim milk, blend, cream, table cream, whipping cream, chocolate partly skim milk and flavoured milk,
- (c) "CMSMC" shall mean the Canadian Milk Supply Management Committee.
- (d) "P5 Target Price" shall mean the prices established for components utilized in each milk class by the five provinces, party to the Agreement on the Eastern Canadian Milk Pooling, that are used as references for all price determinations within the pool.

Component Prices and Billing Factors

> 3. The prices to be paid to Dairy Farmers of Prince Edward Island by processors for each kilogram of butterfat, protein and other solids contained in milk marketed and the standard billing factors, in kilograms per hectolitre of milk, for components used in the manufacture of Class 1 Milk products shall be as follows:

Under the *Natural Products Marketing Act*, R.S.P.E.I.1988, Cap. N-3, and the Dairy Farmers of Prince Edward Island Regulations thereunder, Dairy Farmers of Prince Edward Island makes the following Order:

#### PRODUCER PAYMENT ORDER

Application 1. This Order directs the payment of funds to dairy producers for all milk components marketed from farms in Prince Edward Island.

Definitions 2. The words herein shall have the meanings as found in the Prince Edward Island Natural Products Marketing Act and the Dairy Farmers of Prince Edward Island Regulations unless differentiated herein and as hereinafter defined:

- (a) "Components" means butterfat, protein and other solids contained in milk.
- (b) "Unscheduled Pick-Up" means the removal of milk from the farm for sale to a processor by a licensed dairy transporter, or by any other means, at a time other than the normal time scheduled by the milk transporter assigned to pick up milk on that farm.

Component Prices
Paid to Producers

3. Producers shall be paid for the components present in the milk they offer for sale and sell to the Board, or to a purchasing agent designated by the Board, based on the provisions outlined in this Order. The prices for those components shall be determined under the Agreement on the Eastern Canadian Milk Pooling, net of any valid adjustments, fees, costs and levies determined by the Board.

In-quota Production

- 4. All components produced each month within the limits permitted by a producer's quota holdings and not subject to other payment adjustments established in this Order, any other Board Order, or any other regulation or Order applicable to the production and marketing of milk, shall be paid on a per kilogram basis established by calculating:
  - a) The total revenue for each component paid to the Board by milk processors, net of any adjustments or allowances;
  - b) Adding or subtracting any additional revenue or payments due under regional and national pooling arrangements or any other agreements that the Board is participating in;
  - c) Adding or subtracting any additional funds resulting from the application of Board Orders; and
  - d) Dividing the resulting total revenue for each component by the number of kilograms of each component marketed within quota limits that month.

Over Quota Production

5. Producers shall be paid \$0 for components contained in milk marketed that exceeds their quota limits in any month. However, normal levies for transportation, administration and promotion will be applied to any milk so marketed. Any advance payment for milk produced that is later determined to be over quota shall be recovered through adjustments to the producer's final payment for that month, advances in future months or any other monies payable to that producer from the Board.

Unscheduled Milk Pick Up

6. Producers shall be paid \$0 for the components contained in milk that is removed from a farm by an unscheduled pick-up at their own request, unless that request was made because of a bona fide equipment failure or other operational emergency. Normal levies for transportation, administration and promotion will be applied to all milk marketed through unscheduled pick ups.

Net Produces Revenues

7. Net monthly revenue for each producer is calculated by multiplying the component prices established in Sections 3. and 4. of this Order by the number of kilograms of each component contained in the milk marketed in the month, net of any valid adjustments and levies determined by the Board.

Deductions

8. Producers shall have monthly fees and levies deducted from their net monthly revenues for services rendered, including transportation, promotion, administration, milk testing, taxes and other deductions.

Revocation 9. DFPEI Order 2011-02 effective the 1st day of February 2011 is hereby revoked.

Commencement

10. This Order comes into force on the 1st day of August 2011.

ORDER: DFPEI 2011-08 EFFECTIVE: 1 August 2011

Under the Dairy Farmers of Prince Edward Island Regulations and the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N–3, Dairy Farmers of Prince Edward Island makes the following Order:

#### Canadian Quality Milk Program Order

Application

1. This order establishes the process for participation in the Canadian Quality Milk Program as a quality standard for dairy farms in Prince Edward Island.

Definitions

- 2. The words herein shall have the meanings as found in the Prince Edward Island Natural Products Marketing Act and the Dairy Farmers of Prince Edward Island Regulations under the Act, unless differentiated herein and as hereinafter defined:
  - (a) "Canadian Quality Milk Program" means a program developed under the auspices of Dairy Farmers of Canada and technically recognized by the Canadian Food Inspection Agency that provides standards for milk production based on HACCP practices.
  - (b) "CQM" means the Canadian Quality Milk Program.
  - (c) "HACCP" as set out in Hazard Analysis and Critical Control Point System and Guidelines for its Applications: Annex to the Recommended International Code of Practice General Principles of Food Hygiene (CAC/RCP 1- (1969), Rev. 3 (1997), a hazard analysis critical control point system is science-based and systematic, and identifies specific hazards and measures for their control to ensure the safety of food. HACCP is a tool for assessing hazards and establishing control systems that focus on prevention, rather than rely mainly on end product testing.

(d) "Validation" is the process of evaluation to ensure compliance with CQM standards. It may be accomplished through an independent evaluation of on-farm CQM records or through a self-declaration, as directed by the Board.

Mandatory Program 3. CQM establishes on-farm practices that are designed to meet the requirements of due diligence for food safety in the production of milk. Failure to comply with CQM increases the risk of compromising the safety of milk while it is in production or under the care and control of the producer. Therefore, compliance with this order is mandatory. Dairy producers must be registered in the CQM program or they shall be deemed to be noncompliant with this order.

Record Keeping

4. All specific forms and documents required for CQM record keeping are contained in the CQM Workbook, copies of which are available from the Board office and are supplied to producers on demand. In any instance where alternate forms of record keeping are desired, Board personnel shall provide guidance and assistance to ensure the alternate forms of record keeping meet CQM requirements.

Validation

5. Validation is the process of evaluation to ensure compliance with CQM standards. The validators who perform the evaluation are employed or contracted by the Board, and must complete a specified course of training and on-the-job experience to be employed in that role. A validator shall be assigned by the Board to perform the validation. The validator shall complete a validation checklist as a means of determining the producer's compliance with CQM standards (a copy of the validation checklist is provided to all producers and is available through the Board office). The validation checklist classifies each CQM standard as a major compliance, minor compliance, or demerit point item. Validation must be completed at least annually, as scheduled by the Board, in accordance with the methods specified in the CQM Reference Manual and may be required more often if there is evidence that a producer is not meeting CQM standards.

A self-declaration is a form of validation that permits the producer to remit a questionnaire and any supporting documents to the Board, and does not require a physical examination of records by a validator.

A producer shall not be eligible for registration if validation (including a self-declaration) demonstrates:

- a. One or more major compliance deficiencies;
- b. Five or more minor compliance deficiencies;
- c. On the first validation, 10 or more demerit point deficiencies;

d. On the second and subsequent validations five or more demerit point deficiencies.

COM Standards

6. CQM standards are established in the CQM Reference Manual, which is available to all dairy producers in Prince Edward Island. A dairy producer must meet the CQM standards as established in the manual to achieve registration in CQM. Edits to the reference manual are forwarded to dairy producers as they are released. (For convenience, the list of program standards below is broken into categories of related items denoted by bold print category headers. Where applicable, numbers in brackets at the end of each item are the reference numbers for that item on the validation checklist.) In accordance with CQM reference manual a dairy producer shall:

#### Dairy Facilities, Pesticides and Nutrient Management

- a. Hold a current registration number that is issued by Dairy Farmers of PEI to be able to ship milk (1);
- b. Use only pesticides registered for use in the milk house, barn and fields (2);
- c. Use registered pesticides according to their labels and pre-harvest intervals to harvest or grazing guidelines shall be followed (3);
- d. Store pesticides, treated seed and fertilizer in a safe, secure manner according to provincial dairy regulations (4);
- e. Ensure that an anti-backflow device is installed on any hose used for filling pesticide sprayers or containers that is connected to the milk house or barn water system (5);
- f. Ensure that animal husbandry, manure and waste management systems sustain the cleanliness of lactating cattle's udders (6);
- g. Restrict cattle access to manure storage or manure run-off (7);
- h. Clear the lane-way and loading area of manure contamination at the time of milk pick-up (8);
- i. Acquire the appropriate approval and permits if using sewage sludge (9);

#### Feed

- j. Establish and implement a standard operating procedure if using medicated feeds (13);
- k. Clearly mark storage containers for medicated feeds that have milk or meat withdrawals, or are prohibited for use in lactating cattle, so the feed can be identified by those who handle it (14);
- 1. Store and handle pet foods or feeds that are labeled not for use for ruminants (i.e. clearly labeled with the warning: Feeding this product to cattle, sheep, deer or other ruminants is illegal and is subject to fines or other punishment under the Health of Animals Act) to avoid feeding to cattle or cross-contaminating feeds for cattle (15);

#### **Animal Health and Biosecurity**

- m. Identify all cattle according to the National Livestock Identification for Dairy (NLID) program, or according to Agri-Tracabilité Québec (ATQ) (18);
- n. Identify all cattle to allow for the maintenance of treatment records (e.g. ear tags) (19);

#### Medicines and Chemicals Used on Livestock

- o. Maintain a list of all medicines and chemicals that are used on livestock (23);
- p. Store medicines, chemicals, syringes and needles used on livestock in a clean and sanitary manner, in a dedicated place, and according to label directions (24);
- q. Store and handle medicines and chemicals used on livestock in a manner that will not contaminate milk, meat, or feeds (25);
- r. Store livestock medicines and chemicals for non-lactating and lactating dairy cattle, and products not intended for dairy cattle in a separate area or cupboard (26);
- s. Use only livestock medicines (including medicated foot-baths) that are approved in Canada for use in dairy cattle, and use them according to the label, or according to written veterinary prescriptions. Obtain written veterinary prescriptions for every treatment administered not according to the label and for every veterinary drug used that is not approved for use in Canada (27);
- t. Record the identity of any animal and treatment site for any treatment that resulted in an irretrievable broken needle (28);
- u. Mark all treated cattle in the milking herd to identify those that have milk withdrawals (e.g. leg bands) (29);
- v. Maintain a permanent written record of all medicines and chemicals used on livestock that have a milk or meat withdrawal (30);
- w. Establish and implement a standard operating procedure for treating cattle (31);
- x. Record all problems that occur following treatments administered to animals and the corrective actions that were taken (32);

#### Milking Management

- y. Establish and implement a standard operating procedure for pre-milking and milking (35, 36);
- z. Clean, sanitize and dry teats thoroughly before milking (e.g. manure and teat dips removed) using approved products (37);
  - aa. Establish and implement a standard operating procedure to minimize the risk of shipping abnormal milk (38);

#### **Milking Treated Animals**

- bb. Establish and implement a standard operating procedure to minimize the risk of shipping milk from treated cattle (39);
- cc. Follow the recommended milk withdrawal times for medicated feeds, livestock pesticides and livestock medicines (including ensuring that when an animal calves or aborts that the withdrawal time for any dry cow treatment given has been followed) (40);
- dd. Test the milk from a newly purchased animal for inhibitors before the milk enters the bulk tank and do not ship the milk unless results are negative and results are recorded, or the purchaser must obtain a letter of guarantee from the previous owner covering the last 60 days (41);
- ee. Record any problems that occur regarding milk residues and the corrective actions that were taken (42);

#### Cooling and Storage of Milk

- ff. Record the bulk tank temperature after every milking (43);
- gg. Record any problems that occur regarding cooling and storage of milk and the corrective actions that were taken (44);
- hh. Use approved cleaning products according to the accessible milk house cleaning and sanitizing chart (46);
- ii. Inspect and record the cleanliness of milking equipment on a regular basis (e.g. receiver jar and bulk milk tank) (minimum acceptable frequency is monthly, weekly is recommended) (47);
- jj. Check and record the end temperature of the wash water (hot detergent cycle) once a month (48);
- kk. Record any problems that occur regarding equipment sanitation and wash water temperature and the corrective actions that were taken (49);
- II. Establish and implement a standard operating procedure for post-milking system cleaning (50); mm. Complete annually, a professional evaluation of the wash system and correct any deficiencies that are identified (51);
- nn. Use the milk house exclusively for cooling and storing milk and for cleaning, sanitizing, and storing materials and equipment used in the production and handling of milk (52);
- oo. Store cleaning chemicals in a location and manner that will prohibit the contamination of milk (53);
- pp. Keep the milk house and external surfaces of the milking and milk storage equipment clean at all times (54);
- qq. Implement a functioning safety switch or fail-safe system to avoid accidental entry of wash water into the tank (55);
- rr. Remove all mercury thermometers and vacuum columns from the milk house (56);
- ss. Cover all lights near the bulk tank opening with a protective covering or use bulbs with a protective safety coating (57);

#### **Use of Water for Cleaning Milk Contact Surfaces**

- tt. Test water that is used for milking equipment sanitation annually to ensure that it meets the microbiological parameters determined by the provincial authority and be able to provide water test results upon request (59);
- uu. Record any problems that occur regarding water quality and the corrective actions that were taken (60);

#### **Shipping Animals**

vv. Follow the recommended meat withdrawal times for livestock medicines, livestock pesticides and medicated feeds (61);

ww. Establish and implement a standard operating procedure to minimize the risk of shipping treated animals and animals carrying physical hazards (e.g. broken needles) (62);

xx. Record any problems that occur regarding shipping animals and the corrective actions that were taken (63);

#### Training Farm Staff & Communicating with CQM Staff

yy. Train existing and new staff to implement or maintain the CQM program on farm and grant all staff access to standard operating procedures, corrective action plans and records that are developed and maintained (64);

zz. Keep written corrective action plans on how to communicate and address the following situations (65) -

- I. Incorrect administration of medications or other chemicals to an animal;
- II. Entry of milk from a treated animal into the bulk milk tank;
- III .Improperly cooled or stored milk;
- IV. Failure to properly clean milk contact surfaces;
- V. Improper water temperature;
- VI. Milking equipment water contaminated with bacteria; and
- VII. Sale of a treated animal, or an animal with a broken needle and the buyer was not informed;

#### Other

aaa. If previously registered, the producer must conform to the use of the registration certificate guidelines, which are provided with all registration certificates;

bbb. Any major changes that occur on the farm between validations must be dealt with appropriately to meet the COM requirements; and

ccc. All corrective actions from the previous validation must be addressed.

#### Registration

7. A producer who has completed all mandatory CQM requirements as demonstrated by a completed validation, and who has not exceeded the permitted validation deficiencies, as described in Section 5, shall be registered in CQM. If CQM requirements have not been met, outstanding corrective actions required for registration must be completed to program standards within three months of validation. If registration is not completed in that three month period, the producer shall be given formal notice that failure to comply within one month will result in revocation of registration. If the producer does not comply within one month a further extension of 15 days may be granted by the Board if the producer has demonstrated that the required actions are in progress.

If a validation is completed through a self-declaration, the self-declaration must be completed and returned to the Board not more than one month after the request and form have been presented to the producer. Failure to return a self-declaration in the allotted time shall result in the Board giving formal notice to the producer that failure to comply within one month following the formal notice will result in immediate revocation of registration.

A producer who has failed to achieve registration within the periods defined in this section must reapply to be validated at the producer's expense.

#### Revocation of Registration

8. When a producer who has previously been registered in CQM fails to meet CQM standards on any validation, as specified in section 7, the Board shall revoke that producer's registration.

Failure to Comply

- 9. A dairy producer who has not completed the CQM requirements, who has not achieved CQM registration or who has failed to meet CQM standards resulting in revocation of CQM registration, has failed to comply with the requirements of this order and shall be deemed non-compliant with CQM and this order. A dairy producer who is non-compliant with this order shall:
  - a. be prohibited from selling or offering to sell milk for a minimum of seven days and until such time as that producer has demonstrated to the Board, or a committee designated by the Board, that he has implemented a plan to regain CQM registration and has completed the minimum requirements for a conditional registration as established in Section 11 of this order;
  - b. at the discretion of the Board, be required to appear before the Board, or the designated committee, to present a detailed plan to regain registration;
  - c. be granted a conditional registration as described in Section 11 of this order when the conditions outlined in Sections 9.a and 9.b of this order have been met; or
  - d. be prohibited from selling milk indefinitely if the producer has failed to complete the requirements established in Sections 9.a and 9.b of this order.

#### New Producers

10. A new producer who has completed the requirements outlined in Section 11 of this order shall be granted a Conditional Registration.

#### Conditional Registration

11. A conditional registration is intended to allow the dairy producer time to: commence operations, establish practices and create documents required for CQM; record at least three months of operating data as required by CQM; and be validated. It is also intended to permit a producer who has been deemed non-compliant with this order to be re-instated as a milk producer and support their efforts to become compliant with this order.

A conditional registration shall be granted to producers described in Sections 9 and 10 above, provided they meet and maintain the conditions outlined in this Section. A conditional registration shall be issued for a period not exceeding six months and may be immediately revoked at the direction of the Board if a producer is not following the conditions of this section. If a conditional registration is withdrawn the producer shall be deemed non-compliant with CQM.

- a. A producer shall be granted a conditional registration if they have:
  - i Implemented a plan for achieving CQM registration;
  - ii Received approval for the plan as described in Section 9 above, if required; and
  - iii Completed all requirements of the program up to the date the conditional registration is granted.
- b. A producer who has been granted a conditional registration shall ensure that:
  - All records related to the CQM program are maintained as directed in the CQM Reference Manual;
  - ii. All CQM records are available for verification as required;
  - iii. A copy of all records completed during the conditional registration period, in accordance with the CQM Reference Manual are submitted to the Board on a weekly basis as specified in the registration plan;
  - iv. In any instance where records are maintained by an electronic means, such as a digital time-

temperature recorder, the equipment must be available for random verification by representatives of the Board;

c. If a producer has not achieved CQM registration during the term of a conditional registration, the conditional registration may not be renewed or extended without the review and approval of the Board or a committee designated by the Board.

#### Commencement

12. This Order comes into force on the 1st day of August 2011.

Revocation

13. DFPEI order 2010-12 is hereby revoked.
