**WILDLIFE CONSERVATION ACT
HUNTING AND TRAPPING SEASONS REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 6 September 2011.)

Pursuant to section 28 of the *Wildlife Conservation Act* R.S.P.E.I. 1988, Cap. W-4.1, Council made the following regulations:

1. Schedules I and II of the *Wildlife Conservation Act* Hunting and Trapping Seasons Regulations (EC330/99) are revoked and Schedules I and II as set out in the Schedule to these regulations are substituted.

2. These regulations come into force on September 17, 2011.

EXPLANATORY NOTES

SECTION 1 amends the Schedules to the regulations that outline hunting seasons and limits and trapping seasons for game and fur-bearing animals in the province.

SECTION 2 provides for the commencement of these regulations.
