1. This Order amends Licensing Order PMCMB07-05 dated and effective November 23, 2007.

Amendment

2. Section 6 of Board Order PMCMB07-05 is hereby deleted and the following substituted therefore:

Suspension, revocation and refusal to issue

a license

- 6. (a) The Board may suspend, revoke or refuse to issue a license where the applicant or licensee is not qualified by experience, financial responsibility, or equipment, to engage properly in the business for which application is made or where the applicant or licensee has failed to observe, perform or carry out any condition of the license.
- (b) To be eligible for a license, a producer must
- (i) be certified under the On-Farm Food Safety Assurance Program adopted by the Board for poultry producers; and
- (ii) be certified under the Animal Care Program adopted by the Board for poultry producers.
- (c) The Board may grant a producer a conditional license where the producer has enrolled in the On-Farm Food Safety Assurance Program or the Animal Care Program but has not yet been certified.
- (d) Where the Board intends to suspend, revoke or refuse to issue a license, the Board shall give to the licensee by mail, addressed to him at his address recorded in the books of the Board, notice of its intention to suspend, revoke or not issue the license, as the case may be, and such notice shall fix a time of not less than 30 days from the mailing thereof for the licensee to show cause why the license should not be suspended, revoked or not issued.

3. This Order shall come into force on the 20th day of May, 2011.
