Notice *Legal Profession Act*

Pursuant to Section 55 of the *Legal Profession Act*, S.P.E.I. 1992, Cap. 39, the Law Society of Prince Edward Island approved the following amendments to the *Legal Profession Act* Regulations at its Mid-Winter Meeting on January 27, 2012.

That the Regulations be amended as follows:

Delete existing Regulation 6(d) and replace with the following:

6. (d) a Credentials Committee to examine the character and fitness of applicants pursuant to Section 16 of these Regulations.

Delete Regulation 16(8)(a) and replace with the following:

16. (8)(a) appoint three members of the Credentials Committee, who have not participated in the matter, to act as a Credentials Hearing Panel;

Delete Regulation 49(5)(a) and replace with the following:

49. (5)(a) approve the application with or without conditions,

Delete Regulation 54(3) & 54(5)(a) and replace with:

54. (3) Each Committee may hear and adjudicate any formal complaint, but no Committee may hear or adjudicate a formal complaint which arises out of an investigation in which the Committee has participated, other than pursuant to Section 61.

54. (5)(a) The hearing of a formal complaint in accordance with Section 60, and of a show cause hearing in accordance with Section 63, shall be conducted by a panel of at least five individuals selected from a Committee by the chair of such Committee, who shall also choose a chair from among the members of the panel.

Delete Regulations 61(1) and 61(5) and replace with the following:

61.(1) After a formal complaint is prepared pursuant to subsection 60(2), the member or articulated clerk may, at any time prior to the commencement of the hearing, tender to the investigating Committee a proposed settlement agreement, consented to by counsel for the Society, that includes a statement of sufficient facts in relation to the complaint against the member or articulated clerk to support the admitted charges and proposed disposition, an admission of guilt by the member or articulated clerk to one or more of the charges and the consent of the member or articulated clerk to a specified disposition, conditional upon the acceptance of the agreement by the investigating Committee.

61.(5) Following receipt of the resolution made by the investigating Committee pursuant to subsection (4), the Secretary-Treasurer may release the settlement agreement to in accordance with section 62(3).
