**ROADS ACT
HIGHWAY ACCESS REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated May 14, 2013.)

Pursuant to subsection 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

1. Schedule C-3, LOCAL (CLASS 3) HIGHWAYS, of the *Roads Act* Highway Access Regulations (EC580/95) is amended by the addition of the following after subsection 1(65):

(65.1) **Route 239:** The unpaved portion of Route 239, commencing at the intersection of Route 231 in the settlement of Millvale to the intersection of Route 254 in the settlement of Stanley Bridge.

(65.2) **Route 240:** The unpaved portion of Route 240 in the settlement of Stanley Bridge, commencing at the intersection of Route 224, southerly for a distance of 1.53 km.

2. Schedule D, SEASONAL HIGHWAYS, of the regulations is amended by the addition of the following after subsection 1(33):

(33.1) **Route 240 North Road:** North Road in the settlement of Stanley Bridge, commencing at a point 1.53 km from the intersection of Route 224, southerly for a distance of 1.36 km.

3. These regulations come into force on May 25, 2013.

EXPLANATORY NOTES

SECTION 1 classifies the unpaved portion of Rte 239 and approximately 860 m of Route 240, North Road, from Non-essential to Local Class 3 highway.

SECTION 2 classifies the unpaved portion of Route 240 beginning at a point 1.53 km south of Route 224 southerly for approximately 1.36 km from Non-essential Highway to Seasonal Highway.

SECTION 3 provides for the commencement of these regulations.

Pursuant to section 147 of the *School Act* R.S.P.E.I. 1988, Cap. S-2.1, Council made the following regulations:

1. Subsection 1(1) of the *School Act* Education Negotiating Agency Regulations (EC45/95) is amended

(a) in clause (a), by the deletion of the words “Department of Education” and the substitution of the words “Department of Education and Early Childhood Development”; and

(b) by the revocation of clause (c) and the substitution of the following:

(c) two representatives from the English Language School Board, nominated by the school board from employees who are non-union supervisory staff; and

(d) one representative from the French Language School Board, nominated by the school board from employees who are non-union supervisory staff.

2. Subsection 1(2) of the regulations is revoked.

3. Section 2 of the regulations is amended by the deletion of the words “Minister of Education” and the substitution of the words “Minister of Education and Early Childhood Development”.

4. Section 3 of the regulations is revoked and the following substituted:

- 3.** A quorum shall consist of a minimum of Quorum
- (a) two representatives appointed under clause 1(1)(a);
 - (b) the representative nominated under clause 1(1)(b);
 - (c) one representative nominated under clause 1(1)(c); and
 - (d) the representative nominated under clause 1(1)(d).

5. These regulations come into force on May 25, 2013.

EXPLANATORY NOTES

SECTION 1 amends clause 1(1)(c) of the regulations to provide for representation on the Education Negotiating Agency by two representatives from the new English Language School Board and one from the French Language School Board. All three representatives are nominated by their respective school board from employees who are non-union supervisory staff. It also amends clause 1(1)(a) to update the name of the Department.

SECTION 2 revokes subsection 1(2) of the regulations to remove a restriction that limits each school board to only one representative.

SECTION 3 corrects a reference to the title of the Minister of Education and Early Childhood Development.

SECTION 4 revokes section 3 of the regulations and substitutes a new section 3 to provide that a quorum of the Agency consists of two of the members appointed under clause 1(1)(a), the member nominated under clause 1(1)(b), one of the English Language School Board representatives nominated under clause 1(1)(c) and the French Language School Board representative nominated under clause 1(1)(d).

SECTION 5 provides for the coming into force of these regulations.
