TO ALL TO WHOM these presents shall come or whom the same may in any wise concern:

GREETING A PROCLAMATION

WHEREAS in and by section 11 of Chapter 24 of the Acts passed by the Legislature of Prince Edward Island in the Session thereof held in the year 2010 and in the fifty-ninth year of Our Reign intituled "An Act to Amend the Provincial Court Act" it is enacted as follows:

"This Act comes into force on a date that may be fixed by proclamation of the Lieutenant Governor in Council."

AND WHEREAS it is deemed expedient that the said Act, Stats. P.E.I. 2010, c. 24 should come into force on the 22nd day of June, 2013,

NOW KNOW YE that We, by and with the advice and consent of our Executive Council for Prince Edward Island, do by this Our Proclamation ORDER AND DECLARE that the said Act being "An Act to Amend the Provincial Court Act" passed in the fifty-ninth year of Our Reign shall come into force on the twenty-second day of June, two thousand and thirteen of which all persons concerned are to take notice and govern themselves accordingly.

IN TESTIMONY WHEREOF We have caused these Our Letters to be made Patent and the Great Seal of Prince Edward Island to be hereunto affixed.

LIQUOR CONTROL ACT REGULATIONS **AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated June 11, 2013.)

Made by the Prince Edward Island Liquor Control Commission and approved by the Lieutenant Governor in Council under the Liquor Control Act R.S.P.E.I. 1988, Cap. L-14:

- 1. Section 17 of the Liquor Control Act Regulations (EC704/75) is amended by the deletion of the words "1:00 a.m." and the substitution of the words "2:00 a.m.".
- 2. Section 26 of the regulations is revoked and the following substituted:
- 26. Subject to the Act and orders of the Commission, a licensee may Hours for serving serve liquor in the licensed premises of a lounge on every day of the liquor week between the hours of 9:00 a.m. and 2:00 a.m. the following day.

- 3. Section 37 of the regulations is revoked and the following substituted:
- 37. Subject to the Act and orders of the Commission, a licensee may serve liquor in the licensed premises of a club on every day of the week between the hours of 9:00 a.m. and 2:00 a.m. the following day.

Hours for serving liquor

4. Section 43 of the regulations is revoked and the following substituted:

43. Subject to the Act and orders of the Commission, a licensee may liquor serve liquor in the licensed premises of a military canteen on every day of the week between the hours of 9:00 a.m. and 2:00 a.m. the following day.

Hours for serving

- 5. Clause 50.2(3)(f) of the regulations is amended by the deletion of the words "1:00 a.m." and the substitution of the words "2:00 a.m.".
- 6. These regulations come into force on June 22, 2013.

EXPLANATORY NOTES

SECTION 1 extends the hours of operation of a licensed dining room, in respect of each day of the week, by permitting sales to continue until 2:00 a.m. of the following day. Currently, such a premises must close at 1:00 a.m. of the following day.

SECTION 2 extends the hours of operation of the licensed premises of a lounge, in respect of each day of the week, by permitting sales to continue until 2:00 a.m. of the following day. Currently, such a premises must close at midnight on Sunday, and at 1:00 a.m. following any other day.

SECTION 3 extends the hours of operation of a licensed premises of a club, in respect of each day of the week, by permitting sales to continue until 2:00 a.m. of the following day. Currently, such a premises must close at midnight on Sunday, and at 1:00 a.m. following any other day.

SECTION 4 extends the hours of operation of a licensed premises of a military canteen, in respect of each day of the week, by permitting sales to continue until 2:00 a.m. of the following day. Currently, such a premises must close at midnight on Sunday, and at 1:00 a.m. following any other day.

SECTION 5 extends the hours, in respect of each day of the week, during which a holder of a caterer's license may serve liquor by permitting service to continue until 2:00 a.m. of the following day. Currently, such service must cease at 1:00 a.m. of the following day.

SECTION 6 provides for the commencement of these regulations.
