Definitions 3. In this Order:

- (a) "distributor" means a person engaged in selling or distributing fluid milk products directly or indirectly to consumers, and for better certainty includes a processor, but does not include a storekeeper;
- (b) "home delivery" means the price charged by a processor or a distributor to a consumer for delivery of a Class 1 milk product directly to the home of a consumer;
- (c) "processor" means a person engaged in the processing of Class 1 milk or a Class 1 milk product; and



EC2014-53

FREEDOM OF INFORMATION AND PROTECTION OF PRIVACY ACT GENERAL REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated January 28, 2014.)

Pursuant to section 77 of the *Freedom of Information and Protection of Privacy Act* R.S.P.E.I. 1988, Cap. F-15.01, Council made the following regulations:

- 1. Clause 14(c) of the *Freedom of Information and Protection of Privacy Act* General Regulations (EC564/02) is amended by the deletion of the words "subsection 4(2)" and the substitution of the words "subsection 4(3)".
- 2. These regulations come into force on February 1, 2014.

EXPLANATORY NOTES

SECTION 1 amends a reference to a provision of the *Adult Protection Act* R.S.P.E.I. 1988, A-5 to reflect recent amendments to that Act.

SECTION 2 provides for the commencement of these regulations.
