**HIGHWAY TRAFFIC ACT**  
**PROVINCIALY APPROVED SCREENING DEVICES**  
**REGULATIONS**  
**AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated November 12, 2014.)

Pursuant to subsection 69(1) of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

**1. Clauses 1(a) and (b) of the *Highway Traffic Act* Provincially Approved Screening Devices Regulations (EC226/07) are revoked and the following substituted:**

- (a) a screening device approved by order of the Attorney General of Canada pursuant to section 254 of the *Criminal Code*;
- (b) a breath analysis instrument approved by order of the Attorney General of Canada pursuant to section 254 of the *Criminal Code*.

**2. These regulations come into force on November 22, 2014.**

**EXPLANATORY NOTES**

**SECTION 1** amends the regulations by deleting the names of specific screening devices and instruments and referring instead to the screening devices and instruments approved under the *Criminal Code*.

**SECTION 2** provides for the commencement of these regulations.
