**ENVIRONMENTAL PROTECTION ACT
EXCAVATION PITS REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated October 6, 2015.)

Pursuant to section 25 of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, Council made the following regulations:

1. Subsection 4(4) of the *Environmental Protection Act* Excavation Pits Regulations (EC753/90) is amended by the deletion of the words “clauses (1)(d),” and the substitution of the words “clauses (1)(d), (d.1),”.

2. These regulations come into force on October 17, 2015.

EXPLANATORY NOTES

SECTION 1 amends subsection 4(4) of the regulations to add clause 4(1)(d.1) to the provisions the Minister may decide to waive in order to issue a permit for a pit for a period not to exceed 6 months. Clause 4(1)(d.1) applies where any part of a pit is within 500 metres of a church, school, hospital or other specified public place.

SECTION 2 provides for the commencement of the regulations.

MATERIALS STEWARDSHIP AND RECYCLING
REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated October 6, 2015.)

Pursuant to section 25 of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, Council made the following regulations:

1. Section 59 of the *Environmental Protection Act* Materials Stewardship and Recycling Regulations (EC349/14) is amended**(a) by the addition of the following after clause (d):**

(d.1) “glycol product” includes a container with a capacity of up to 50 litres manufactured for the purpose of holding glycol; glycol product

(b) by the addition of the following after clause (f):

(f.1) “oil product” includes a container with a capacity of up to 50 litres manufactured for the purpose of holding an oil product and includes aerosol containers as well as aerosol containers used to contain products used as brake cleaner; oil product

2. Subsection 63(3) of the regulations is amended by the deletion of the words “oil, oil filters or glycol products” wherever they occur and the substitution of the words “oil products, oil filters, or glycol products”.**3. These regulations come into force on October 17, 2015.****EXPLANATORY NOTES**

SECTION 1 clarifies that oil and glycol containers, as well as aerosol containers for brake cleaner, are included within the regulations.

SECTION 2 remedies a terminological inconsistency in subsection 63(3) and brings it in line with the phrase used in the rest of Division 4.

SECTION 3 provides for the commencement of these regulations.
