(a) by the deletion of the words “EN 303-5” wherever they occur and the substitution of the words “BS EN 303-5”;

(b) by the revocation of clause (1)(a); and

(c) in subsection (2),

(i) in the words preceding clause (a), by the addition of the words “on request” after the word “documentation”,

(ii) by the revocation of clause (c),

(iii) in clause (d), by the deletion of the words “that has been witnessed by the approved inspection agency”, and

(iv) in clause (e), by the deletion of the word “test”.

(4) Section 5 of the Schedule to the regulations is amended

(a) by the deletion of the words “EN 303-5” and the substitution of the words “BS EN 303-5”;

(b) by the revocation of clause (1)(b); and

(c) in subsection (2),

(i) in the words preceding clause (a), by the addition of the words “on request” after the word “documentation”,

(ii) by the revocation of clause (c), and

(iii) in clause (f), by the deletion of the words “, as witnessed and verified by the approved inspection agency”.

23. These regulations come into force on November 28, 2015.

SECTION 13 amends subsection 10.03(1) of the regulations to modernize the wording and to update a reference to CSA standard CSA Z7396.1-12.

SECTION 14 amends clause 10.07(c) of the regulations to update a reference to CSA Z7396.1-12.

SECTION 15 amends section 10.09 of the regulations to update a reference to CSA standard CSA Z305.1-92.

SECTION 16 amends subsections 11.08(2), (3) and (4) of the regulations to update references to CSA standard CSA B-52-13.

SECTION 17 amends section 11.11 of the regulations to delete a reference to an ANSI Code and substitute a reference to the applicable current ASME Code. The ANSI organization no longer issues codes.

SECTION 18 amends section 11.35 of the regulations to clarify that the standard applicable to pressure relief devices is CSA B-52-13.

SECTION 19 amends section 11.39 of the regulations to update a reference to CSA B-52-13 and to clarify that the applicable requirements are contained in Annex B of that standard. The section also changes references to “Group 2 refrigerant” to “other refrigerant”, for consistency with the Standard.

SECTION 21 amends subsection 11.48(3) to update a reference to CSA B-51-14.

SECTION 22 amends specified clauses of the Schedule to the regulations to update the applicable standards, eliminate labelling requirements that duplicate existing requirements in applicable standards and other requirements that have proved to be unnecessary.

SECTION 23 provides for the commencement of the regulations.
