PLANT HEALTH ACT
POTATOES REGULATIONS
AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated December 23, 2015.)

Pursuant to section 6 of the *Plant Health Act* R.S.P.E.I. 1988, Cap. P-9.1, Council made the following regulations:

1. Section 1 of the *Plant Health Act* Potatoes Regulations (EC138/95) is amended

(a) by the revocation of clause (b);

(b) in clause (e), by the deletion of the words “Department of Agriculture and Forestry” and the substitution of the words “Department of Agriculture and Fisheries”; and

(c) by the revocation of clause (f).

2. The heading immediately before section 7 of the regulations and sections 7 and 7.1 of the regulations are revoked.

3. Section 8.1 of the regulations is revoked.

4. These regulations come into force on January 2, 2016.

EXPLANATORY NOTES

SECTION 1 revokes the definition of “approved disinfection station”. These disinfection stations are being discontinued. The section also corrects the name of the Department, and revokes a definition of “disinfection” that is inconsistent with the definition in the Act.

SECTION 2 revokes sections 7 and 7.1. The disinfection program provided for in these sections is being discontinued.

SECTION 3 revokes section 8.1, which dealt with fees for disinfection services, for consistency with the revocation of sections 7 and 7.1.

SECTION 4 provides for the commencement of these regulations.
