AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated January 5, 2016.)

Made by the Prince Edward Island Liquor Control Commission and approved by the Lieutenant Governor in Council under the *Liquor Control Act* R.S.P.E.I. 1988, Cap. L-14:

1. Section 54.1 of the *Liquor Control Act* Regulations (EC704/75) is revoked.

2. These regulations come into force on January 16, 2016.

EXPLANATORY NOTES

SECTION 1 revokes section 54.1 of these regulations, which required training in beverage service for license holders and persons serving liquor. Requirements respecting training in beverage service are now provided for in the Act.

SECTION 2 provides for the commencement of these regulations.
