**ORDER**

**WHEREAS** subsection 36(1) the *Municipal Government Act*, R.S.P.E.I. 1988, Cap. M-12.1 requires every municipal council, at least 90 days before an election, to pass a bylaw in accordance with the regulations, with respect to campaign contributions, spending limits and disclosure requirements;

AND WHEREAS municipal elections are scheduled to occur on November 5, 2018, except in the Resort Municipality where the municipal election is scheduled to occur August 13, 2018;

AND WHEREAS subsection 36(1) requires municipal councils, except for the municipal council for the Resort Municipality, to have the bylaw referred to therein passed on or before August 6, 2018;

AND WHEREAS due to the limited number of times many municipal councils meet during the months of June, July and August, it may be difficult for a number of councils to have the bylaw required under subsection 36(1) passed on or before August 6, 2018;

AND WHEREAS under subsection 8(2) of the Act, I have the authority to make an order extending the time required to do something under this Act;

EC2018-328

**PLANNING ACT  
SUBDIVISION AND DEVELOPMENT REGULATIONS  
AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated May 29, 2018.)

Pursuant to sections 8 and 8.1 of the *Planning Act* R.S.P.E.I. 1988, Cap. P-8, Council made the following regulations:

**1. Subsection 42(1) of the *Planning Act* Subdivision and Development Regulations (EC693/00) is amended**

(a) in clause (d), by the deletion of the word “or” after the semicolon;

(b) in clause (e), by the deletion of the period and the substitution of the words “; or”; and

(c) by the addition of the following after clause (e):

(f) for institutional use on the property located at civic address 2661 Heatherdale Road, Route 316.

**2. These regulations come into force on June 9, 2018.**

### EXPLANATORY NOTES

**SECTION 1** amends subsection 42(1) of the Subdivision and Development Regulations to add an exception for multiple buildings for institutional uses, in this case dormitories, located at 2661 Heatherdale Road, Route 316.

**SECTION 2** provides for the commencement of the regulations.
