Pursuant to section 72 of the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30.1, Council made the following regulations:

**1. Clause 1.1(1)(d) of the *Public Health Act* Notifiable Diseases and Conditions and Communicable Diseases Regulations (EC560/13) is amended**

**(a) by the revocation of subclause (i) and the substitution of the following:**

- (i) carbapenemase-producing *Enterobacteriaceae*,
- (i.1) *Clostridium difficile*,

**(b) by the addition of the following after subclause (iii):**

- (iii.1) extensively drug-resistant *Enterobacteriaceae*,

**2. These regulations come into force on July 15, 2017.**

**EXPLANATORY NOTES**

**SECTION 1** prescribes carbapenemase-producing *Enterobacteriaceae* and extensively drug-resistant *Enterobacteriaceae* as notifiable diseases or conditions.

**SECTION 2** provides for the commencement of these regulations.
