Payment Limit

Payments for solids not fat delivered by a milk producer in each calendar month shall be limited to a maximum number of kilograms of protein and other solids represented by two and twenty-five one hundredths (2.25) multiplied by the producer's kilograms of butterfat production delivered in the same calendar month.

Application of Payment

4. Any funds retained as a result of producers exceeding the limit stated in Section 3 shall be paid pro-rata based on butterfat production to those producers who have marketed milk containing solids not fat less than or equal to two and twenty-five one hundredths (2.25) times the number of kilograms of butterfat produced that month.

Revocation 5. Dairy Farmers of Prince Edward Island Order DFPEI 2012-08, is hereby revoked.

Commencement 6. This Order comes into force 1 August 2022.

ORDER: DFPEI 2022-06 EFFECTIVE: 1 September 2022

Under the Dairy Farmers of Prince Edward Island Regulations and under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N–3, Dairy Farmers of Prince Edward Island makes the following Order:

#### CREDIT TRANSFER ORDER

Application

 This order establishes a system for the transfer of production credits between quota holders that are allotted quota by DFPEI.

Definitions

- 2. (1) The words herein shall have the meanings as found in the *Natural Products Marketing Act*, the Dairy Farmers of Prince Edward Island Regulations under that Act.
  - (2) In this order:
    - (a) "credit" means an unused unit of milk production, equal to 1Kg of butterfat quota, that is created when daily quota is not filled to its maximum potential, including any flexibility granted by DFPEI to manage milk production, as permitted by the quota credit system;
    - (b) "credit purchaser" means a producer who has obtained credits from other producers;
    - (c) "credit transfer" is the assignment of one or more credits from one producer to another, which may be for a fee;
    - (d) "credit transfer exchange" means an exchange established, controlled and operated by DFPEI for the transfer of credits between producers;
    - (e) "credit vendor" means a producer who has transferred credits to other producers;
    - (f) "DFPEI" means Dairy Farmers of Prince Edward Island;
    - (g) "milk" includes whole milk and such products of milk that are supplied, processed, distributed or sold in any form;
    - (h) "producer" means a person, partnership or company that produces milk for sale;
    - "quota" means a dairy producer's share of the market for milk as fixed and allotted by DFPEI; and
    - (j) "quota credit system" means a mechanism established by DFPEI that allows milk producers to over ship up to a maximum of ten (10) times their daily quota on a cumulative basis, referred to as over quota production credits, or to under ship up to a maximum of thirty (30) times their daily quota on a cumulative basis, referred to as under quota production credits.

Credit Transfer 3.

Credits may be transferred between producers and any credit transfers shall be transacted under the conditions established by this order. 4.

Credit Transfer Exchange DFPEI may operate a credit transfer exchange to facilitate credit transfers between producers. All transactions through the exchange shall be subject to the limits and conditions created in this order as well as any additional limits or conditions created in that order.

Direct Producer to Producer Transfers

 A producer is permitted to transfer credits directly to or from another producer, without participation in the credit transfer exchange.

Credit Transfer Quantities and Limits Credits may be transferred in quantities expressed in kilograms of butterfat, rounded to zero decimal places. The quantity of credits an individual producer may transfer at any one time shall be limited to an amount specified from time to time by DFPEI. The specified maximum number of credits a producer may purchase or sell each month, effective 1 April 2021, shall be equal to not more than twenty-five percent (25%) of the production permitted by the producer's quota for the calendar month in which the transfer occurs. For this calculation, the production permitted for the calendar month the credit transfer occurs is calculated by multiplying the producer's current daily quota allocation by the number of days in the calendar month.

Reduced Transfer
Limits for Quality 7.
Violations

Notwithstanding S.6 (above) the number of credits a producer may transfer in a month shall be reduced under the following circumstances:

- (a) a producer that has incurred one (1) violation resulting in penalties in the preceding 12 months, as specified in the current DFPEI Violations and Penalties Order, shall be limited to purchasing not more than twenty percent (20%) of the production permitted by the producer's quota for two calendar months following the month in which the violation occurred, provided they do not incur additional violations during those two months.
- (b) a producer that has incurred two (2) violations resulting in penalties in the preceding 12 months, as specified in the current DFPEI Violations and Penalties Order, shall be limited to purchasing not more than ten percent (10%) of the production permitted by the producer's quota for the three calendar months following the month in which the second violation occurs, provided they do not incur additional violations during those three months;
- (c) a producer that has incurred three (3) or more violations resulting in penalties in the preceding 12 months, as specified in the current DFPEI Violations and Penalties Order, shall be prohibited from purchasing credits for the four calendar months following the month in which the last violation occurs, provided they do not incur additional violations during those four months.

Producer to

Producer Contracts 8. All producer-to-producer credit transfers shall be registered with DFPEI using a credit transfer contract form provided by the Board. Contracts must be delivered to the DFPEI office by close of business on the twenty-fifth day of the month of transfer. Where the twenty-fifth of a month falls on a weekend or a statutory holiday, the board shall accept producer-to-producer contracts until close of business on the next business day.

Contract

 A registration fee of \$20.00 shall be paid to DFPEI to administer all direct producerto-producer credit transfer contracts.

Transfers

All payments for credit purchases made by a producer-to-producer credit transfer agreement shall be payable to Dairy Farmers of Prince Edward Island. Payments

shall be disbursed to credit vendors by DFPEI. Payments must be received at the DFPEI office by 4PM on the second business day following the deadline for contract submission.

#### Default of Payment

- 11. Default of payment occurs when a payment is not delivered to the DFPEI office by close of business on the last business day of the calendar month in which the transfer occurs; or if a payment instrument delivered for settlement of a credit purchase is dishonoured. In the event of default of a payment for credit transfer:
  - A) DFPEI shall require the credit purchaser to deliver guaranteed payment sufficient to pay the cost of the purchase, contract registration fee and any service charges related to the default that are levied by third parties; by bank draft, electronic transfer, or comparable payment method to the DFPEI office within 2 business days of notification of the default; and
  - B) the producer that has defaulted shall be prohibited from purchasing credits in the month following the month of default.

#### Right of Offset

12. In the event of a default of payment for a transfer for which a producer is unable to provide guaranteed payment within 2 business days, as outlined in section 10, DFPEI shall retain the right to offset the indebtedness created by the default of payment against future revenues for milk sales, credit sales or quota sales.

#### Assignment

prohibited

- 13. Credits may not be assigned to lenders. A producer's obligation created by an assignment of quota to a lender is not relieved by any credit transfer transaction.

Under the Dairy Farmers of Prince Edward Island Regulations and under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, Dairy Farmers of Prince Edward Island makes the following Order:

#### MILK PRODUCER QUOTA EXCHANGE ORDER

Application

 This Order provides for the establishment, control and operation by the Board of a Quota Exchange to be operated for milk producers.

Definitions

- 2. The words herein shall have the meanings as found in the Prince Edward Island *Natural Products Marketing Act* and the Dairy Farmers of Prince Edward Island Regulations unless differentiated herein, and as hereinafter defined:
  - (a) "cleared" shall mean the process by which the Board shall conduct the buying and selling of quotas which results in the purchase and sale of quotas.
  - (b) "daily quota" shall mean the amount of kilograms of butterfat quota assigned to a producer by the Board, expressed to two decimal places.
  - (c) "exchange month" shall mean the calendar month in which a producer's quota shall be adjusted by the amount of quota purchased or sold on the exchange.
  - (d) "exchange clearing price" shall be the price at which the amount of quota offered for sale on an exchange equals, or comes closest to, the amount of quota bid for, except that where the volume is the same for more than one price, the lowest price shall be used.

Exchange

Established

3. The Board hereby establishes a quota exchange, to be operated by the Board, for the purchase and sale of daily quota held by milk producers.

Eligible

Producers

Only producers registered by the Board shall be eligible to participate on the quota exchange.

Purchasing prohibition

5. Any producer who has incurred two or more violations resulting in penalties in the preceding 12 months, as specified in the current DFPEI Violations and Penalties Order, shall be prohibited from purchasing quota through the exchange beginning with the first exchange to clear following the month in which the last violation occurred. This prohibition shall continue until the producer has recorded three consecutive months of production without incurring another violation resulting in a penalty.

Maximum

offer price

6. The price at which milk producers may offer to sell or purchase quota on the exchange is limited to a maximum offer price as established from time to time by the Board. The maximum price permitted as of 1 September 2021 is twenty-four thousand dollars per Kg of daily quota.

Bids to be

Excluded

Any bid to purchase or sell quota that exceeds the maximum offer price as determined by the Board shall be excluded from the exchange and returned to the bidder. Offer amounts

8. Producers may offer to sell or purchase any amount of daily quota in increments of 0.1 kilograms, except when a producer sells all their quota the sale shall be measured to two decimal places. A producer may not offer to sell more than the amount of their quota holdings.

Offer forms

Producers offering to sell or purchase quota on the exchange shall only submit offers on a form provided by, or approved by, the Board.

Close of the

Exchange and Delivery of Forms

10. The exchange shall close, meaning that no more offers to buy or sell shall be accepted, at normal close of business on the first business day of the month prior to the exchange month. The Board will accept a facsimile copy or a scanned and electronically transmitted copy of an offer to sell or purchase quota.

Change or cancellation of offers

11. A producer may change or cancel an offer to sell or purchase quota provided that such change or cancellation is made in writing and the notice of change or cancellation is received prior to the close of the exchange.

Clearing date

12. The Board shall establish the clearing price, clear the exchange and release the exchange results by noon on the second business day following the closing of the exchange.

Determination of the exchange clearing price

- 13. Offers to sell and offers to purchase quota (bids) shall be used to establish the market clearing price of the exchange in the following manner:
  - Offers to sell quota shall be accumulated based on the prices at which the quota is
    offered for sale, from the lowest to the highest price offered.
  - (2) Bids shall be accumulated based on the prices at which producers have bid for quota, from the highest price to the lowest bid price.
  - (3) The accumulated offers shall be compared to determine the price at which the minimum difference between the volume offered for sale and the volume offered for purchase occurs, which shall determine the exchange clearing price.
  - (4) If no point is reached where the amount of quota offered for sale is equal to, or nearly equals, the amount of quota bid for purchase on an exchange, the exchange shall be deemed to have not cleared and no transactions shall take place on that exchange.

Selection

- 14. Where the amount of quota offered for sale and amount of bids for purchase at the clearing price does not equal, the Board shall distribute the available quota in the following manner:
  - (1) If the amount of quota offered for sale at or below the clearing price is greater than the amount of quota bid for at the clearing price, the Board shall sell the quota offered for sale based on the order in which the offers to sell were received at the board office.
  - (2) If the amount of quota bid for at or above the clearing price is greater than the amount of quota offered for sale at the clearing price, the amount of quota sold shall be distributed in 0.01 kilogram lots until the amount of quota offered for sale at or below the clearing price is fully distributed.
  - (3) Producers are limited to three bids per exchange. If more than three bids are received from one producer, then the lowest priced offers to purchase or the highest

priced offers for sale shall be disqualified and returned to the producer until only three bids from that producer remain.

If a registered producer submits more than one bid to purchase quota and more (4) than one of those bids are at or above the clearing price, they will be accumulated and considered as one bid for the distribution of quota as described in section 13(2) (above).

Settlements

15. Producers offering to purchase quota on an exchange shall provide full payment to the Board for any quota purchased not later than the 20th of the month prior to the exchange month.

#### Deposit

of cheques

16. The Board shall deposit cheques for successful purchases on the 20th of the month prior to the exchange month except where the 20th falls on a weekend or a statutory holiday the Board shall deposit the cheques on the prior business day.

#### Settlements to sellers

Adjustments to

17. The Board shall issue settlements to sellers of quota effective the first (1st) business day of the exchange month.

producer quotas

- 18. The Board shall debit seller's quota with the amount of quota sold and credit purchaser's quota with the amount of quota purchased on the first (1st) calendar day of the exchange month.
- Service charges
- 19. Producers shall pay to the Board a service charge of \$5.00 for each successful offer to sell or purchase quota.

#### Failure to pay

for quota

- 20. Where a producer fails to pay the Board for the amount of quota purchased by the twentieth of the month prior to the exchange month, or where a cheque provided to the Board by a producer in payment of quota purchased has been dishonoured by a financial institution, the Board shall hold the quota in reserve and offer it for sale on the next exchange. A producer who fails to provide payment by the date specified shall be prohibited from purchasing on the exchange for a period of three calendar months.
- Accounting
- 21. The Board shall maintain accounting records for the operation of the exchange and shall submit audited financial statements on the records of the exchange at its annual meeting and make an accounting of its operation based on the fiscal year of the Board.
- Revocation
- 22. Dairy Farmers of Prince Edward Island order DFPEI 2021-04 dated April 1st, 2021 is hereby revoked.

Commencement 23. This Order comes into force on September 1st, 2022.
