**BUILDING CODES ACT
BUILDING CODES REGULATIONS

(Approved by Her Honour the Lieutenant Governor in Council dated September 8, 2020.)

Pursuant to section 32 of the *Building Codes Act* R.S.P.E.I. 1988, Cap. B-5.1, Council made the following regulations:

1. Section 6 of the *Building Codes Act* Building Codes Regulations (EC177/20) is amended by the addition of the following after subsection (4):

(4.1) Where an applicant withdraws an application before a decision is made on it, the authority having jurisdiction may authorize a refund of all or part of a permit fee paid pursuant to these regulations where, in the opinion of the authority having jurisdiction, the withdrawal of the application will avoid public expense. Refund of fee

2. (1) Subsection 38(1) of the regulations is amended

(a) in the words preceding clause (a), by the deletion of the words “an authority having jurisdiction” and the substitution of the words “a council of a municipality”; and

(b) in clause (a), by the deletion of the words “the authority having jurisdiction” and the substitution of the words “the council of the municipality”.

(2) Section 38 of the regulations is amended by the addition of the following after subsection (1):

(1.1) Notwithstanding the qualification requirements specified in section 37, the Minister may appoint as a building official, and specify the appropriate level of the appointment, a person who was previously employed as a building official or a building codes officer by the Minister before these regulations came into force, on receipt of satisfactory evidence of the person’s identity and qualifications. (3) Subsection 38(2) of the regulations is amended

(a) by the deletion of the words “request from the authority having jurisdiction” and the substitution of the words “request from the council of a municipality”; and

(b) by the deletion of the words “employed by the authority having jurisdiction” and the substitution of the words “employed by the council of the municipality”.

(4) Section 38 of the regulations is amended by the addition of the following after subsection (2):

(2.1) Notwithstanding the qualification requirements specified in subsection 37(3), the Minister may appoint a professional engineer or architect employed by the Minister as a Level II building official, on receipt of satisfactory evidence of the person’s identity and qualifications.

EXPLANATORY NOTES

SECTION 1 amends section 6 of the *Building Codes Act* Building Codes Regulations (EC177/20) to add a new subsection (4.1) that authorizes an authority having jurisdiction to refund all or part of a permit fee paid by an applicant who withdraws an application before a decision is made on it, where in the opinion of the authority having jurisdiction the withdrawal will avoid public expense.

SECTION 2 amends subsection 38(1) of the regulations to restrict its application to a previous appointment of a building official made by a council of a municipality, and adds a new subsection 38(1.1) to provide specifically for the appointment of a person as a building official where the person was previously employed by the Minister as a building official or a building codes officer. The section also amends subsection 38(2) and adds a new subsection (2.1) to make similar changes to the appointment of a professional engineer or architect as a Level II building official.

SECTION 3 amends Schedule B to the regulations to revoke item number 17 and substitute a corrected item number 17.

SECTION 4

- revokes Table 1 in Schedule C to the regulations and substitutes a revised Table 1 to clarify the relationship of the size of a project to its permit fee;
- amends Table 2 in Schedule C to the regulations to remove the restricting words “in Table 1” and clarify that it applies to any project listed in the Schedule;
- amends Schedule C to the regulations to add a new Table 4 that sets out a review fee that applies to any project not listed in the Schedule.

SECTION 5 provides for the commencement of the regulations.
