### HEALTH AND DENTAL SERVICES COST ASSISTANCE ACT

## HEALTH AND DENTAL SERVICES COST ASSISTANCE REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated September 12, 2023.)

Pursuant to section 19 of the *Health and Dental Services Cost Assistance Act* R.S.P.E.I. 1988, Cap. H-1.21, Council made the following regulations:

- 1. Subsection 12(2) of the Health and Dental Services Cost Assistance Act Health and Dental Services Cost Assistance Regulations (EC728/20) is amended by the deletion of the words "is limited to a maximum enrollment of three 12-month terms" and the substitution of the words "may claim a benefit in a maximum of three 12-month terms".
- 2. These regulations come into force on September 23, 2023.

#### **EXPLANATORY NOTES**

**SECTION 1** amends subsection 12(2) of the regulations to provide that an eligible person may claim benefits in a maximum of three 12-month terms. A term during which an eligible person is enrolled but does not claim a benefit does not count towards this maximum.

**SECTION 2** provides for the commencement of the regulations.

### **HIGHWAY TRAFFIC ACT**

# POWER-ASSISTED BICYCLES REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated September 12, 2023.)

Pursuant to section 312 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

1. (1) Section 13 of the *Highway Traffic Act* Power-Assisted Bicycles Regulations (EC557/21) is amended by the addition of the following after subsection (5):

### Bicycle manufacture - passenger

- (5.1) Where a power-assisted bicycle is manufactured to carry a passenger and the operator of the power-assisted bicycle is carrying a passenger who is a child, the operator shall ensure that
  - (a) the child shall
    - (i) be six years of age or under,
    - (ii) ride on a seat designed to carry children on bicycles or power-assisted bicycles, and
    - (iii) wear a properly fitted and fastened bicycle safety helmet;
  - (b) the seat designed to carry children shall
    - (i) be an approved child bicycle seat that attaches to a bicycle or power-assisted bicycle,
    - (ii) be firmly attached to the power-assisted bicycle behind the operator's seat, as far forward and in as low a position as is practicable, and
    - (iii) be equipped with
      - (A) a seat belt which is fastened around the child at all times when the power-assisted bicycle is in motion, and
      - (B) a shield to prevent any part of the child's body or clothing from coming into contact with any of the power-assisted bicycle's moving parts.
- (2) Section 13 of the regulations is amended by the addition of the following after subsection (6):

### **Exception - towing**

- (6.1) Despite subsection (6), the operator of a power-assisted bicycle may tow
  - (a) a bicycle trailer designed for transporting passengers, including passengers who are children;
  - (b) a cargo trailer designed to be hauled by a power-assisted bicycle; or
  - (c) an electric motorized cargo trailer that, in combination with the electric motor of a power-assisted bicycle, has a total continuous power output rating of 500 watts or less.

### Safety helmet

- (6.2) The operator of a power-assisted bicycle shall ensure a passenger being transported in a bicycle trailer pursuant to clause (6.1)(a) is wearing a properly fitted and fastened bicycle safety helmet.
- (3) Subsection 13(9) of the regulations is amended by the deletion of the words "subsection (8)" and the substitution of the words "subclause (5.1)(a)(iii) and subsections (6.2) and (8)".
- 2. These regulations come into force on September 23, 2023.

### **EXPLANATORY NOTES**

**SECTION 1** amends section 13 of the *Highway Traffic Act* Power-Assisted Bicycles Regulations (EC557/21) to add three new subsections. Subsection 13(5.1) authorizes the operator of a power-assisted bicycle to operate the bicycle with a passenger who is a child six years of age or under and sets out the requirements for carrying a child passenger. Subsection 13(6.1) is an exception to the prohibition against towing another person, vehicle or device to authorize the operator of a power-assisted bicycle to tow a bicycle trailer, a cargo trailer or an electric cargo trailer. Subsection 13(6.2) requires the operator of a power-assisted bicycle to ensure a passenger being transported in a bicycle trailer wears a properly fitted and fastened bicycle safety helmet. Subsection 13(9) of the regulations is amended to include all provisions that reference a bicycle safety helmet to ensure all helmets meet applicable safety standards.

**SECTION 2** provides for the commencement of the regulations.

# TURKEY MARKETING COMMISSION PLAN REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated September 12, 2023.)

On the recommendation of the Prince Edward Island Marketing Council and under authority of subsections 8(1) and 9(1) and section 29 of the *Natural Products Marketing Act* R.S.P.E.I. 1988, Cap. N-3, Council made the following regulations:

1. The enacting clause of the *Natural Products Marketing Act* Turkey Marketing Commission Plan Regulations (EC686/91) is revoked and the following substituted:

On the recommendation of the Prince Edward Island Marketing Council and under authority of subsections 8(1) and 9(1) and section 29 of the *Natural Products Marketing Act* R.S.P.E.I. 1988, Cap. N-3, Council made the following regulations:

- 2. Section 1 of the regulations is amended
  - (a) in the words immediately preceding clause (a), by the deletion of the words "In this Order" and the substitution of the words "In these regulations"; and
  - (b) in clause (i), by the deletion of the word "his" and the substitution of the words "the person's".
- 3. Subsection 4(5) of the regulations is amended by the deletion of the word "chairman" and the substitution of the word "chairperson".
- **4. Section 6 of the regulations is amended by the deletion of the words** "fieldmen or other employees is personally liable for anything done by

him" and the substitution of the words "field workers or other employees is personally liable for anything done by that person".

5. (1) Subsection 8(3) of the regulations is revoked and the following substituted:

### Removal from register

- (3) The Commission may remove from the register the name of any producer by giving 30 days' notice in writing stating the grounds for removal and mailed to the last known address of the producer recorded in the register.
- (2) Subsection 8(4) of the regulations is amended by the deletion of the words "his name from the register to the Appeals Tribunal. In the event of such appeal, the name" and the substitution of the words "the producer's name from the register to the Appeals Tribunal and the producer's name".
- (3) Section 8 of the regulations is amended by the addition of the following after subsection (4):

### **Appeals procedure**

(5) An appeal under subsection (4) shall be heard in accordance with the Appeals Procedure Regulations (EC142/86) made under the Act.

### 6. Section 16 of the regulations is amended

- in the words preceding clause (a), by the deletion of the word "his" and the substitution of the words "the member's or officer's";
- (b) in clause (a),
  - (i) by the deletion of the word "him" wherever it occurs and the substitution of the words "the member or officer", and
  - (ii) by the deletion of the word "his" and the substitution of the words "the member's or officer's"; and
- (c) in clause (b),
  - (i) by the deletion of the word "he" wherever it occurs and the substitution of the words "the member or officer", and

- (ii) by the deletion of the word "his" and the substitution of the words "the member's or officer's".
- 7. These regulations come into force on September 23, 2023.

### **EXPLANATORY NOTES**

**SECTION 1** replaces the enacting clause of the *Natural Products Marketing Act* Turkey Marketing Commission Plan Regulations (EC686/91) so that the clause refers to the relevant provisions in the Act that authorize the making of regulations in respect of marketing commissions. The section updates the correct reference to the regulations as "regulations" rather than as an "Order in Council", to coincide with the wording of amendments made to the Act.

**SECTION 2** amends section 1 of the regulations to update the wording in the provision to correctly refer to the regulations as "regulations" rather than as an "Order". *The section* replaces a gender-specific term with a gender-neutral term.

**SECTIONS 3 to 6** amend the noted provisions in the regulations to replace gender-specific terms with gender-neutral terms. At section 5 of the amendment a new subsection is added to section 8 of the regulations to specify an appeal under subsection 8(4) of the regulations is to be heard in accordance with the Appeals Procedure Regulations made pursuant to the Act.

**SECTION 7** provides for the commencement of the regulations.
