Under the *Natural Products Marketing Act*, R.S.P.E.I., 1988, Cap. N-3, the Chicken Farmers of Prince Edward Island (formerly Poultry Meat Commodity Marketing Board) Marketing Regulations and the Prince Edward Island Chicken Order made pursuant to the *Agricultural Products Marketing Act* (Canada), the Chicken Farmers of Prince Edward Island makes the following Order:

CHICK PLACEMENT ORDER

1. This Order applies to the control and regulation of chick placements with respect to the production and marketing of chicken in the Province of Prince Edward Island.
2. (1) The meaning of words herein shall be as defined herein or, if not defined, as in the *Natural Products Marketing Act* R.S.P.E.I. 1988, Cap. N -3 and the Chicken Farmers of Prince Edward Island Chicken Farmers Marketing Regulations.

(2) In this order:
 - a) “CFC” means the Chicken Farmers of Canada formed under the *Farm Products Agencies Act* (Canada).
 - b) “Board” means the Chicken Farmers of Prince Edward Island;
 - c) “Chick” means a bird which is ten days or younger that will be raised as a chicken;
 - d) “Chicken” means a chicken of any class or parts thereof produced in the Province of Prince Edward Island, but does not include a chicken that is;
 - I. Five months or older,
 - II. Ten days or younger, or
 - III. Used in egg production;
 - e) “Permit” means a permit issued by the Board authorising a producer to purchase chicks;
 - f) “Producer” means any person who raises chicken for processing, for sale to the public, or for use in products manufactured by him;
 - g) “License” means a permit issued by the Board for production and marketing of chicken other than that produced under a quota.
3. A producer who produces and markets poultry meat from less than 500 chickens in a calendar year is exempt from this order.
4. No producer shall purchase chicks without prior approval of the Board.
5. A producer shall not be entitled to purchase chicks if;
 - a) The producer is not in possession of a quota or license issued by the Board;

- b) Such purchase might result in the production and or marketing of chicken in excess of the producer's quota;
 - c) The producer is in arrears in the payment of charges or levies imposed by the board.
 - d) The producer has failed to submit reports to the board;
 - e) The producer is unwilling to allow the board or CFC to count the number of chickens in the producer's production facilities;
 - f) The producer is otherwise in violation of the Act, Regulations or Orders of the board; and
 - g) If the purchase of chicks, when placed in production would result in the province exceeding its provincial quota allocation.
6. When a producer raises his own chicks from eggs hatched by him, a purchase shall be deemed to have occurred when the chicks are one-day old and the producer shall make an application under paragraph 5 of the order seven days prior to hatching.
7. Approval by the board shall be in such form as may be prescribed by the board.
8. Board Order PMCMB07-04 is hereby revoked.
9. This Order shall be effective this 18th day of October 2017.

EFFECTIVE: October 18th, 2017

Under the *Natural Products Marketing Act*, R.S.P.E.I., 1988, Cap. N-3, the Chicken Farmers of Prince Edward Island (formerly Poultry Meat Commodity Marketing Board) Marketing Regulations and the Prince Edward Island Chicken Order made pursuant to the *Agricultural Products Marketing Act* (Canada), the Chicken Farmers of Prince Edward Island makes the following Order:

LICENSING ORDER

1. This Order applies to the licensing of producers and processors with respect to the control and regulation of the production and marketing of chicken in the Province of Prince Edward Island.
2. (1) The meaning of words herein shall be as defined herein or, if not defined, as in the *Natural Products Marketing Act* R.S.P.E.I. 1988, Cap. N -3 and the Chicken Farmers of Prince Edward Island Chicken Farmers Marketing Regulations.

(2) In this order:
 - a) “CFC” means the Chicken Farmers of Canada formed under the *Farm Products Agencies Act* (Canada).
 - b) “Board” means the Chicken Farmers of Prince Edward Island;
 - c) “Chicken” means a chicken of any class or parts thereof produced in the Province of Prince Edward Island, but does not include a chicken that is;
 - I. Five months or older,
 - II. Ten days or younger, or
 - III. Used in egg production;
 - d) “Processor” means any person engaged in the slaughtering of chicken.
 - e) “Producer” means any person who raises chicken for processing, for sale to the public, or for use in products manufactured by him.
 - f) “License” means a permit issued by the Board for production and marketing of chicken other than that produced under a quota.
3. A person who produces or markets poultry meat from less than 500 chickens in a calendar year is exempt from this order.
4. (a) No person shall engage in the production or marketing of chicken produced in Prince Edward Island unless the person holds an appropriate license issued by the Board and pays to the Board a fee prescribed for that license established by the Board from time to time.

(b) The following types of licenses are hereby established by the Board:

-
- (i) Producer License
 - (ii) Processor License
- (c) Where a person operates in more than one capacity in the marketing of chicken, the person shall apply to the Board for a license in each capacity.
 - (d) A license does not entitle a producer to any rights other than those specifically stated in the license and shall not confer any rights to receive additional license or quota for the same or any other class of chicken.
 - (e) A license issued by the Board shall expire on the 31st day of December of the year of issue.
 - (f) Every license shall be issued subject to the following conditions:
 - 1) The licensee shall provide to the board such reports and information as the board may from time to time require;
 - 2) The licensee shall permit any person authorised by the board to inspect the licensee's premises and records as it relates to the production and/or marketing of chicken, and;
 - 3) The licensee shall at all times during the term of the license comply with all orders and regulations of the board.
- 5. Application for license shall be made in a form provided by the board and shall include such information that the Board deems necessary to properly assess the application.
 - 6. The license must be produced on the land and in the production facilities described in the application and the license may not be sold, transferred, assigned, subleased or divided in any manner.
 - 7. A provincial production cap has been established by Quota Order CFPEI 16-02 and may be revisited as required.
 - 8. The maximum number of birds that an applicant places will be determined by the total number of live kilograms allotted, divided by the anticipated live weight per bird to market. The maximum shall only be allotted if it is supported by the business and marketing plan submitted and the production facility confirmation of same.
 - 9. Should an applicant request an increase in the number of live kilograms in the second and subsequent years from the initial year, the requested increase must be supported by the appropriate production facilities, hatchery, and the ability to successfully market those birds.
 - 1. If the provincial bird cap would be utilized by applications received by January 15th licenses will be issued as follows; applicants will first be allotted an amount equal to their license in the previous year
 - 2. If the provincial cap is not fully utilised by the licenses issued above, consideration to allocating any requested increases in license proportionally based on the number of birds requested as compared to the number of birds remaining available to all applicants until the provincial cap has been fully utilised.

3. If the provincial cap has not been fully realised by January 15th all complete applications after that date will be considered on a first come, first serve basis;
4. First time applications will only be considered after February 15th and only if the provincial cap has not been fully utilised.
10. (a) The Board may suspend, revoke or refuse to issue a license where the applicant or licensee is not qualified by experience, financial responsibility, or equipment, to engage properly in the business for which application is made or where the applicant or licensee has failed to observe, perform or carry out any condition of the license.
- (b) To be eligible for a license, a producer must
- 1) Be certified under the On-Farm Food Safety Assurance Program adopted by the Board for poultry producers; and
- 2) Be certified under the Animal Care Program adopted by the Board for poultry producers.
- (c) The board may grant a producer a conditional license where the producer has enrolled in the On-Farm Food Safety Assurance Program or the Animal Care Program but has not yet been certified.
- (d) Where the board intends to suspend, revoke or refuse to issue a license, the board shall give to the licensee by mail addressed to him at his address recorded in the books of the board, notice of its intention to suspend, revoke or not issue the license, as the case may be, and such notice shall fix a time of not less than 30 days from the mailing thereof for the licensee to show cause why the license should not be suspended, revoked or not issued.
11. Board Order PMCMB07-05 and CFPEI 11-01 are hereby revoked.
12. This Order is effective October 18th, 2017.

EMPLOYMENT STANDARDS ACT EXEMPTION REGULATIONS

(Approved by His Honour the Lieutenant Governor in Council dated October 17, 2017.)

Pursuant to section 41 of the *Employment Standards Act* R.S.P.E.I. 1988, Cap. E-6.2, Council made the following regulations:

1. In these regulations, “Act” means the *Employment Standards Act* Act, defined R.S.P.E.I. 1988, Cap. E-6.2.
2. Athletes while engaged in activities related to their athletic endeavours are exempt from the application of sections 5, 6 to 15.1, 17 and 29 of the Act. Exemption
3. These regulations come into force on October 28, 2017. Commencement

EXPLANATORY NOTES

SECTION 1 defines “Act” to mean the *Employment Standards Act* R.S.P.E.I. 1988, Cap. E-6.2.

SECTION 2 exempts a class of employees--athletes while engaged in activities related to their athletic endeavours--from sections in the Act that relate to the minimum wage, paid holidays, vacation pay, hours of work, reporting pay and notice of termination.

SECTION 3 provides for the commencement of these regulations.
