GREETING
A PROCLAMATION

WHEREAS in and by section 4 of Chapter 45 of the Acts passed by the Legislature of Prince Edward Island in the First Session thereof held in the year 2015 and in the sixty-fourth year of Our Reign intituled “An Act to Amend the Workers Compensation Act” it is enacted as follows:

“This Act comes into force on a date that may be fixed by proclamation of the Lieutenant Governor in Council.”,

AND WHEREAS it is deemed expedient that the said Act, Stats. P.E.I. 2015, c. 45 should come into force on the 15th day of October, 2016,

NOW KNOW YE that We, by and with the advice and consent of our Executive Council for Prince Edward Island, do by this Our Proclamation ORDER AND DECLARE that the said Act being “An Act to Amend the Workers Compensation Act” passed in the sixty-fourth year of Our Reign shall come into force on the fifteen day of October, two thousand and sixteen of which all persons concerned are to take notice and govern themselves accordingly.

IN TESTIMONY WHEREOF We have caused these Our Letters to be made Patent and the Great Seal of Prince Edward Island to be hereunto affixed.

FINANCE PEI ACT

**REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated October 18, 2016.)

Pursuant to section 13 of the *Finance PEI Act* R.S.P.E.I. 1988, Cap. F-8.1, Council made the following regulations:

1. Section 5 of the *Finance PEI Act* Regulations (EC739/12) is revoked.

2. These regulations come into force on October 22, 2016.

EXPLANATORY NOTES

SECTION 1 revokes section 5 of the *Finance PEI Act* Regulations. That section purported to give the power to approve the write-off of debts to the board. However, the power to authorize the write-off of debts is given to the Lieutenant Governor in Council by section 26.1 of the *Financial Administration Act* R.S.P.E.I. 1988, Cap. F-9.

SECTION 2 provides for the commencement of the regulations.
